WHEREAS, in accordance with Title 48, Section 716, Arizona Revised Statutes, and following public notice, the Board met on June 15, 2015 at which hearing any taxpayer in the District was privileged to appear and be heard in favor or against any of the proposed expenditures or tax levies.

NOW THEREFORE, BE IT RESOLVED that the Wildflower Ranch Community Facilities District No. 2 (City of Goodyear, Arizona) Budget in the amount of \$229,991 is hereby adopted as the Budget of the Wildflower Ranch Community Facilities District No. 2 (City of Goodyear, Arizona), for the fiscal year 2015-2016.
