4.1 **PR 121-13** Recognition for Boy Scout, Daniel Benvenuto.

Matthew Ligouri, Assistant to the Council, introduced Daniel Benvenuto, who assisted staff and directed 20 volunteers in completing the Historic Goodyear Alleyway Painting Project on April 13, 2013. Mayor Lord read a letter of recognition.

4.2 **PR 122-13** Proclaim May as Building Safety Month.

Ed Kulik, Chief Building Officer and representing Arizona Building Officials, reported that May is "Building Safety Month". The event is sponsored by the International Code Council Foundation. Mayor Lord read a Proclamation.

4.3 PR 125-13 National Kids to Parks Day

David Seid, Recreation Supervisor, presented an overview of the "National Kids to Parks Day". Goodyear Community Park will be hosting an event to commemorate "National Kids to Parks Day" on Saturday, May 18, 2013. Mayor Lord read a proclamation.

7. BUSINESS

7.1 13-5007 <u>CONTRACT WITH RED OAK CONSULTING FOR SCADA PHASE</u> <u>II PROJECT</u> RECOMMENDATION:

Authorize the City Manager to approve a lump sum contract for Professional Engineering Services with Red Oak Consulting for Supervisory Control and Data Acquisition (SCADA) Phase II - Development Services Project, and authorize the Purchase Order to be issued for \$647,750.

Brad Richards, Project Manager, presented. Richards reviewed the background and project objectives of the Supervisory Control and Data Acquisition (SCADA) System. Phase II will add to the data acquisition functions, implement and expand supervisory control, and allow remote monitoring and control from the SCADA Control Center. Phase II will build upon Phase I and will continue to improve support operations, monitoring and data collection at individual sites. The SCADA system is secure from cyber threats. This project is funded from the Capital Improvement Program (CIP). The \$647,750 contract with Red Oak Consulting is \$104,066 less than the approved, budgeted amount. The additional funds will be used for equipment purchases and contingencies as required for the project during development.

MOTION BY Councilmember Pizzillo, SECONDED BY Councilmember Lauritano, to authorize the City Manager to approve a lump sum contract for Professional Engineering Services with Red Oak Consulting for Supervisory Control and Data Acquisition (SCADA) Phase II - Development Services Project, and authorize the Purchase Order to be issued for \$647,750. 7.2 13-5011 <u>AMENDMENT 1, GMP 2 TO THE CM@RISK CONTRACT WITH D.</u>

L. WITHERS FOR CONSTRUCTION OF PHASE I AND II OF THE GOODYEAR OPERATIONS CENTER DECOMMENDATION:

RECOMMENDATION:

Authorize the City Manager to approve Amendment 1, GMP 2 to the CM@Risk construction contract not to exceed the Guaranteed Maximum Price (GMP) amount of \$2,401,196.00 for the Goodyear Operations Center Phase I and Phase II Projects (FA1102 and FA 1201) and authorize purchase order to be issued.

Regis Reed, Senior Project Manager, presented an overview and background of the Goodyear Operations Center Phase I and Phase II Project, and recapped Council discussion from the March 18, 2013 Special Meeting. At that meeting, Council asked for additional information from staff regarding the GMP2 portion of the contract pertaining to the Public Works Wash and Fuel Station Facility. Staff was asked to bring back project changes to the Wash and Fuel Facility so that it remains within the parameters of its original budget and not impact the existing funding for the Public Works Fleet Facility. Staff was also asked to conduct a traffic study and make recommendations on the Romley Road intersection at Estrella Parkway, and options for the 159th Avenue and MC-85 entrance to the project area.

Reed presented project details for Phase I and Phase II of the Goodyear Operations Center as outlined below.

Goodyear Operations Center:

- Streets Lay Down Yard for material storage and vehicle staging
- Fueling facility with 3 fuel tanks
- Vehicle Wash Facility for large vehicles (project scope reduced)
- Train Depot as identified in the 2011 Master Plan for the Operational Center The location for Train Depot will be considered as part of 2013 Parks Master Plan

Fleet & Equipment Management Facility:

- Located immediately north of the Wash Facility and adjacent to infrastructure installed
- Facility includes eight bays with room to grow
- Designed to provide service for 15 years
- Design allows for expansion as needed without significant interruption

Reed recapped the engineers' cost estimate and the fiscal impact of the project. Construction will begin in August 2013 and will be complete in April 2014.

David Ramirez, City Engineer, presented an overview on Romley Road access to the site and recommended traffic improvements. Costs for Romley Road are estimated at \$270,000 and are included in the project budget.

Ramirez summarized the Traffic Signal Warrant Study. Results of the study show that no traffic signals are warranted at this time.

Recommended Improvements:

>Northbound left turn lane at Romley Road

>Southbound right turn lane at Romley Road >Southbound right turn lane at Roeser Road >Restrict vehicular access onto Roeser Road and redirect traffic to Romley Road

Staff is not recommending 159th Avenue access at this time due to low vehicle counts and the cost/benefit analysis for additional expenses for improvements to MC-85. The cost of fully-improved access is not within the budget.

Council Discussion:

>Concern with trucks and heavy equipment running up Estrella Parkway, since it is the gateway to the Estrella Community.

>Acknowledged that we don't have the money to add the 159th Avenue access at this time, but stressed that it can be readdressed in the future when the Train Depot is opened.

Reed responded that staff is working with ADOT to create access off MC-85 for future development. This will be a priority when funding is available, however, this is not included in the current five-year Capital Improvement Plan (CIP).

City Manager Dalke interjected that Council will be periodically reviewing CIP funding priorities. If it is decided that funding for the 159th Avenue access road is needed sooner, it can be moved up on the prioritization schedule.
