ASSESSMENT HEARING

Chairman Lord opened the public hearing at 4:35 p.m.

Chairman Lord read that this is the time and place set for the hearing on the assessment and proceedings for the Estrella Mountain Ranch Community Facilities District (City of Goodyear, Arizona), Montecito Assessment District No. 2. The Board of Directors of the District initiated the improvements in the District and the improvements have been completed.

Notice of this hearing has been mailed to each property owner. At this hearing, this Board must determine if the construction is complete, if the assessment is fair and equitable under all circumstances, if the amounts assessed are equal to or less than the benefits received by each respective parcel assessed, and rule on all other objections raised. The District has no monetary interest in the outcome of this hearing. No Board member may have an interest in any lot or parcel covered by the assessments. Each owner of each assessed parcel has agreed to the assessment.

Larry Lange, District Treasurer, presented. This meeting is the fourth meeting for setting assessments on certain undeveloped areas within Estrella Mountain Ranch Montecito Assessment District No. 2. The Board previously adopted the assessment roll based on estimates. Bonds were authorized and issued and other necessary actions were taken. The infrastructure is now complete and the Board is being asked to adopt the recapitulated assessment, which includes all the final costs, by approving Resolution 15-098.

Chairman Lord closed the public hearing at 4:39 p.m.
