

ORDINANCE NO. 2020-1471

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AMENDING ARTICLE 3-13 (PARKS AND RECREATION ADVISORY COMMISSION) SECTION 3-13-4 (COMMISSION MEMBERSHIP AND TERM) OF THE GOODYEAR CITY CODE; PROVIDING SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Mayor and Council of the City of Goodyear, established the Parks and Recreation Advisory Commission on July 9, 2013 pursuant to Ordinance 12-1265; and

WHEREAS, On December 3, 2012, the Parks and Recreation Advisory Commission was reduced from nine members to seven voting members, and removed the requirement of one member from the Planning and Zoning Commission to participate on the Commission, pursuant to Ordinance 12-1270.

WHEREAS, on August 18, 2014, an alternate non-voting member to the Parks and Recreation Advisory Commission was added which would designate the alternate to immediately fill a vacant position, in the event a future vacancy should occur, pursuant to Ordinance 14-1305; and

WHEREAS, the current membership requirement states the Commission shall consist of seven voting volunteer advisory members and three ex officio non-voting members, consisting of the one student member, the City Manager or designee, and the Director; and

WHEREAS, there is a desire to update ex officio memberships by removing the City Manager or designee and adding the option for a designee for the Parks & Recreation Director; and

WHEREAS, the Mayor and Council of the City of Goodyear, Arizona believe it is in the best interest of the City to amend Subsection 3-13-4(A) (Commission Membership and Term) of Article 3-13 of Goodyear City Code to update ex officio memberships.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. SUBSECTION 3-13-4 (A) (Commission Membership and Term) of Article 3-13 (Parks and Recreation Advisory Commission) of the Goodyear City Code is amended to read as follows:

3-13-4 COMMISSION MEMBERSHIP AND TERM.

(A) The Commission shall consist of seven voting volunteer advisory members and one alternate, non-voting member. In addition to the seven Commission members, there shall be two ex officio non-voting members, which will consist of one student member and the Director or designee.
