Approve the issuance of two (2) utility easements to Arizona Public Service Company, an Arizona corporation (APS), for the Goodyear Police Operations Facility.

## **PURPOSE:**

Construction of the Goodyear Police Operations Facility is currently underway. As part of the construction process, APS requires utility easements to place, operate and maintain the electrical equipment required to provide electricity to the facility. (Linda R. Beals, Real Estate Coordinator)

# 6.4 16-5858 INTERGOVERNMENTAL AGREEMENT WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION (ADOT) FOR THE PURCHASE OF TRAFFIC SIGNS.

# **RECOMMENDATION:**

Authorize the City Manager or designee to execute an Intergovernmental Agreement (JPA 15-0005688-I) with the Arizona Department of Transportation

for the purchase of traffic signs with Federal funds, and authorize a budget transfer to expend the Federal funding.

## **PURPOSE:**

This project will inventory traffic signage in Goodyear and allow for the identification of any signage that needs to be replaced. A Fiscal Year (FY)16 project has been approved by the Maricopa Association of Governments for the replacement of signage. (Ron Sievwright, Streets and Traffic Superintendent)

# 6.5 16-5851 AMENDMENT TO AN IGA WITH THE REGIONAL PUBLIC TRANSIT AUTHORITY FOR THE PROVISION OF TRANSIT SERVICES RECOMMENDATION:

Authorize the City Manager to approve an Amendment to the Intergovernmental Agreement (IGA) between the city of Goodyear and the Regional Public Transit Authority (RPTA) for the provision of transit services in Goodyear.

# **PURPOSE:**

The current IGA establishes responsibilities for the provision of transit services in Goodyear, including Fixed Route Bus Service, reimbursement of Americans with Disabilities Act (ADA) Public Transportation Funds and administration of the ADA Platinum Pass program for a five-year period. The amendment presented for consideration herein, transfers the cost of the ADA Platinum Pass program from the city to the RPTA, adds the obligation for the city to provide Regional Dial-a-Ride (RDAR) service and updates the cost for the city to provide Fixed Route Bus Services (Avondale Zoom service) for Fiscal Year 2017. # 6.6 16-5865 ACCEPTANCE OF THE 2015 ASSISTANCE TO FIREFIGHTERS GRANT AWARD

# **RECOMMENDATION:**

Ratify the acceptance of the 2015 Assistance to Firefighters grant award in the amount of \$32,728, authorize the City Manager to approve an expenditure of \$3,272 from the grant match fund required for the grant match, approve an FY17 budget transfer for the grant award and execute all documents related to grant management.

# **PURPOSE:**

The purpose of the Assistance to Firefighters Grant Program (AFG) is to enhance the safety of the public and firefighters with respect to fire and fire-related hazards by providing direct financial assistance to eligible fire departments, non-affiliated EMS organizations and State Fire Training Academies for critically needed resources to equip and train emergency personnel to recognized standards, enhance operational efficiencies, foster interoperability, and support community resilience. ### **PURPOSE:**

This request is to amend the Use Permit for the Compass Church to remove the stipulation prohibiting access onto 161st Avenue. The Church would like to utilize the existing driveway onto 161st Avenue for non-emergency purposes. However, removal of the stipulation prohibiting access would be required for this to occur. Staff finds that the proposed Use Permit amendment will not be a material detriment to surrounding properties and will be reasonably compatible with uses allowed in the surrounding area. The opening of the driveway to non-emergency traffic should not adversely affect residents living along 161st Avenue and Wade Lane. The Planning and Zoning Commission considered this item at its regular meeting of December 16, 2015. The Commission recommendation is denial of the Use Permit amendment. (Steve Careccia, Planner III)

GENERALLY LOCATED ON THE WEST SIDE OF ESTRELLA PARKWAY, SOUTH OF THE ESTRELLA STAR TOWER, TO THE INTERSECTION OF ESTRELLA PARKWAY AND COTTON LANE, BY AMENDING SECTION 2(C) OF ORDINANCE NO. 87-217, AS AMENDED, AND ORDINANCE NO. 13-1288, WHICH APPROVED THE CALLISTO PLANNED AREA DEVELOPMENT FOR THE PROPERTY BY ADOPTING THE LUCERO PLANNED AREA DEVELOPMENT (PAD) AMENDMENT DATED MARCH 18, 2016 TO GOVERN THE DEVELOPMENT OF THE PROPERTY; AMENDING THE ZONING MAP OF THE CITY OF GOODYEAR; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
