Approve draft minutes from a Regular Meeting held on September 26, 2016, and a Regular Meeting held on October 3, 2016.

6.2 <u>16-5873</u> <u>APPROVING THE 2017 CITY COUNCIL MEETING SCHEDULE</u> RECOMMENDATION:

Reschedule the regular City Council meeting normally scheduled on July 24, 2017 to July 17, 2017; the regular meeting normally scheduled on August 14, 2017 to August 21, 2017; the regular meeting normally scheduled on October 09, 2017 to October 2, 2017; the regular meeting normally scheduled on November 27, 2017 to November 20, 2017; the regular meeting normally scheduled on December 25, 2017 to December 18, 2017, and to approve the 2017 City Council Meeting Calendar.

PURPOSE:

6.3 16-5914 ACCEPTING A 2016 GRANT AWARD FROM THE ARIZONA DEPARTMENT OF HOMELAND SECURITY RECOMMENDATION:

Accept the Urban Area Security Initiative (UASI) Chemical, Biological, Radiological, Nuclear, Explosive (CBRNE) Response Team Sustainment/Enhancement Grant of \$50,000 awarded by the Arizona Department of Homeland Security to the Goodyear Police Department, and authorize the City Manager or designee to execute all documents necessary to administer the grant award, including a FY17 budget transfer for \$50,000.

PURPOSE:

The grant will provide additional funding for equipment and training necessary to further capabilities and enhancements to the program. The UASI CBRNE Response Team will continue to provide response to both local and regional hazardous materials incidents and statewide events while maintaining interoperability communication capabilities through the sustainment grant award. The grant is for \$50,000, which is awarded on a reimbursable basis. The

grant period is October 1, 2016 through September 30, 2017. (Jerry Geier, Chief of Police)

6.4 <u>16-5910</u> <u>QUIT CLAIM DEED FOR A PORTION OF ELWOOD STREET</u> RECOMMENDATION:

Accept a Quit Claim Deed from Sun-DS Farms, LLC, an Arizona limited liability company for a portion of Elwood Street located west of Estrella Parkway.

PURPOSE:

The City has requested and Sun-DS Farms, LLC has provided a Quit Claim Deed for a portion of Elwood Street located just west of Estrella Parkway. The Quit Claim Deed is required to complete the transfer of the fee ownership of the 55 foot wide right of way for the north half of the roadway. (Linda R. Beals, Real Estate Coordinator)

6.5 16-5911 EXTENDING THE TEMPORARY SUSPENSION OF PROVISIONS IN THE CITY OF GOODYEAR ENGINEERING DESIGN STANDARDS AND POLICIES MANUAL 2012 EDITION THAT IMPOSE REQUIREMENTS FOR INSTALLATION OF RECLAIMED WATER IMPROVEMENTS

RECOMMENDATION:

ADOPT RESOLUTION 16-1772 EXTENDING THE TEMPORARY SUSPENSION OF PROVISIONS IN THE CITY OF GOODYEAR ENGINEERING DESIGN STANDARDS AND POLICIES MANUAL 2012 EDITION THAT IMPOSE REQUIREMENTS FOR THE INSTALLATION OF RECLAIMED WATER IMPROVEMENTS; PROVIDING AUTHORIZATION AND DIRECTION TO TAKE ACTIONS NECESSARY TO CARRY OUT INTENT OF RESOLUTION; PROVIDING FOR THE TERMINATION OF SUSPENSION; AND PROVIDING FOR AN EFFECTIVE DATE.

PURPOSE:

This action would extend the temporary suspension and application of all provisions in the City of Goodyear Engineering Design Standards and Policies Manual 2012 Edition that impose requirements for the installation of reclaimed water improvements unless the City is a party to a contract in which the City has contractually obligated itself to deliver reclaimed water that Council previously approved before March 31, 2014 by Resolution 14-1607. The extension will allow time for City staff to review and revise the City of Goodyear Engineering Design Standards and Policies Manual 2012 Edition. These standards are currently being reviewed and projected to be ready for Council consideration in the third quarter of calendar year 2017. (Mark Holmes, Water Resources Manager)

6.6 <u>16-5903</u> <u>AMENDING THE PLAT FOR THE COVE AT PALM VALLEY NORTH</u> RECOMMENDATION:

Approve the amendment to the final plat of The Cove at Palm Valley North, subject to stipulations.

PURPOSE:

This amendment adds drainage easements along the common lot lines of the duplexes. These easements are necessary to address the drainage from the roof-lines draining from one lot to another. Other than the new drainage easements, the final plat for The Cove is consistent with the final plat that was approved by City Council on March 14, 2016. (Alex Lestinsky, Planner II)

Approve the \$106,134 Contract Change Order No. 2 to the construction contract for D.L. Withers Construction to complete the construction of the Police Operations Facility.

PURPOSE:

RECOMMENDATION:

Approval of this expenditure allows the city to execute the change order with D.L. Withers Construction to complete the construction services on the 20,910 square foot Police Operations Facility. This request for expenditure includes, but is not limited to items such as; security fencing, air/water station for police vehicles, a canopy over the command/SWAT vehicles, landscaping and completing the police decontamination room.
