

RESOLUTION 14-1616

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF ARIZONA, ACTING BY AND THROUGH ITS DEPARTMENT OF TRANSPORTATION TO ESTABLISH RESPONSIBILITY FOR FUNDING, INSTALLATION AND MAINTENANCE RESPONSIBILITIES OF LANDSCAPING TO BE CONSTRUCTED WITH THE SR303 – THOMAS ROAD TO CAMELBACK ROAD SEGMENT.

WHEREAS, the State of Arizona, through the Arizona Department of Transportation (“ADOT”), is and has been improving State Route (SR) 303 Loop (“SR 303”) to create a six lane freeway between Interstate 17 in Phoenix and Interstate 10 in Goodyear.

WHEREAS, for reasons of aesthetics and sound mitigation, the City would like to see landscaping installed along SR 303.

WHEREAS, ADOT is willing to install landscaping and irrigation improvements along SR 303 between Thomas Road and Camelback Road subject to the City’s agreement to pay certain costs and to assume responsibility for the operation and maintenance of the landscaping and irrigation improvements once installed.

WHEREAS, the attached Intergovernmental Agreement number IGA/JPA 13-0003166-I sets forth the terms under which ADOT is willing to install landscaping and irrigation improvements along SR 303 between Thomas Road and Camelback Road.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, ARIZONA, AS FOLLOWS:

SECTION 1. The Mayor is hereby authorized to execute the attached Intergovernmental Agreement between the City of Goodyear and the State of Arizona number IGA/JPA 13-0003166-I for the design and construction of landscape improvements located at State Route 303 (SR303) between Thomas Road and Camelback Road.
