RESOLUTION NO. 15-1693

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA AUTHORIZING THE ESTABLISHMENT OF A PUBLIC STREET FOR A SECTION OF SHERMAN STREET TO BE CONSTRUCTED, OPENED AND MAINTAINED BY THE CITY; REQUIRING RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to the power vested in the City of Goodyear ("City") by its Charter and pursuant to A.R.S. § 9-276, the Mayor and Council of the City of Goodyear have the power to establish, construct, improve, regulate vacate, and modify roadways open to the public; and

WHEREAS, the City owns a certain parcel of real property consisting of approximately 100 acres (City 100 Acre Parcel) located at the northwest corner of South Estrella Parkway and the alignment of North Goodyear Boulevard (the "City 100 Acre Parcel"); and

WHEREAS, pursuant to that certain Purchase Agreement and Escrow Instructions dated October 31, 2014 by and between the City of Goodyear, an Arizona municipal corporation and Basis Schools, Inc., an Arizona non-profit corporation (the "Purchase Agreement"), the City sold Basis approximately 11 acres of the City 100 Acre Parcel (the "Basis Site") for the development of a charter school; and

WHEREAS, the development of the Basis Site requires the construction of the north half-street road improvements to the existing improvements to Sherman Street (generally from Goodyear Boulevard to the cul-de-sac where Sherman Street currently terminates) (the "Sherman Street Improvements"); and

WHEREAS, the property upon which the Sherman Street Improvements are to be constructed is owned by the City; and

WHEREAS, pursuant to the Purchase Agreement, the City is to construct the Sherman Street Improvements; and

WHEREAS, the City is in the process of designing the Sherman Street Improvements and has prepared legal descriptions for the property within the City 100 Acre Parcel needed for the improvements; and

WHEREAS, the City has not platted the City 100 Acre Parcel and has not established the north half of the Sherman Street alignment where the Sherman Street Improvements are to be constructed as a public road; and

WHEREAS, the Mayor and Council of the City of Goodyear find and determine that the public health, safety, and welfare require the establishment of a public street within the Sherman Street alignment adjacent to the Basis Site, as more particularly described in Exhibit A, attached hereto, to be opened to the public and maintained by the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, ARIZONA, AS FOLLOWS:

SECTION 1. The Mayor and Council of the City of Goodyear find and determine that it is in the interest of the public health, safety and welfare of the City to designate as a public street that portion of the City 100 Acre Parcel, more particularly described and depicted in the Exhibit A attached hereto, and by reference, made a part hereof.

SECTION 2. The City Clerk shall cause a certified copy of this Resolution, including Exhibit A, attested by the City Clerk, to be recorded in the official records of the Maricopa County Recorder.

SECTION 3. That this Resolution shall become effective upon its adoption.


