3.1 REVIEW AND CHANGE PRE-EXISTING CONDITION FORM FOR POSSIBLE ADOPTION

This should be documented by the health care provider and reviewed by the employee.

Kathy Steadman, Counsel Attorney, provided a pre-existing condition form to the Board Secretary to review with the Board to incorporate into the pre-employment application process. She also sent a 30 day pre-existing form letter that she recommended sending to the applicants to advise them they have 30 days to respond to the pre-existing conditions listed on their questionnaire.

Chairman Stipp reviewed the 30 day letter that was sent out to the three employees who state pre-existing conditions and there was some confusion on what the employees needed to provide. The Board discussed and reviewed the letter to make it clearer to the applicants.

3.4 REVIEW RULES OF PROCEDURE FOR POLICE AN DFIRE PUBLIC SAFETY PERSONNEL RETIREMENT BOARDS CONCERNING PRE-EXISTING CONDITON PROCESS

The Board re-worded the letter to make it more clear to the employees, therefore, the Rules of Procedure did not need to change.
