

**RESOLUTION NO. 15-1704**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AMENDING THE MUNICIPAL USER FEE SCHEDULE ADOPTED BY RESOLUTION NO. 10-1357 BY ELIMINATING THE SPECIAL EVENT PERMIT FEES AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Resolution No. 10-1357 approved and adopted a document entitled Goodyear Municipal User Fee Schedule; and

WHEREAS, following a work session on April 13, 2014 during which the Mayor and Council of the City of Goodyear considered changes to Chapter 26 of the Goodyear City Code – Special Events, Mayor and Council adopted Ordinance No. 15-1322 amending various sections of Chapter 26 of the Goodyear City Code – Special Events Ordinance; and

WHEREAS, one of the changes adopted was the elimination of a Special Event Permit Fee; and

WHEREAS, the Goodyear Municipal User Fee Schedule approved and adopted the recommended updated user fees and cost recovery rates to include the Special Event Permit Fees; and

WHEREAS, in light of the adoption of Ordinance No. 15-1322, which amended Chapter 26 of the Goodyear City Code – Special Events, eliminating the Special Event Permit Fee, the Municipal User Fee Schedule needs to be modified to eliminate the Special Event Permit Fee; and

WHEREAS, Exhibit A attached hereto shows the Special Event Permit Fees in the Municipal User Fee Schedule adopted by Resolution No. 10-1357 and that are to be eliminated.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, ARIZONA, AS FOLLOWS:

SECTION 1. The Municipal User Fee Schedule adopted by Resolution No. 10-1357 is hereby amended to eliminate the Special Event Permit Fees reflected in Exhibit A attached hereto.

SECTION 2. This resolution shall be effective on May 11, 2015.
