# 6.1 CFUD#1 AUTHORIZE ISSUANCE AND SALE OF DISTRICT GENERAL 15-484 OBLIGATION REFUNDING BONDS, SERIES 2015, FOR COMMUNITY FACILITIES UTILITIES DISTRICT NO. 1

Larry Lange, Finance Director, presented. This resolution authorizes the issuance and sale of General Obligation Refunding Bonds, Series 2015, for the Community Facilities Utilities District No. 1, not to exceed \$7,015,000. The purpose of the refinancing is to decrease the District's debt service under its outstanding general obligation debt by taking advantage of lower interest rates. The result of this action will net a savings of approximately \$500,000. With this savings, staff anticipates maintaining a property tax rate of \$0.90, which is lower than the current target rate of \$1.00. The property rate for FY2015 was \$0.7662 per \$100 valuation. Actual savings will be based on interest rates in late May to early June, 2015.

#### **Board Discussion:**

>Will the refinancing reset the time period on the debt? Lange responded that we are not extending the time of the debt, and will keep the same time period.

APPROVE FISCAL YEAR 2015-2016 TENTATIVE BUDGET AND SETTING A PUBLIC HEARING DATE FOR THE GOODYEAR COMMUNITY FACILITIES GENERAL DISTRICT NO. 1 BUDGET

Larry Lange, Finance Director, presented on behalf of Sheila Mills. He presented the proposed tentative budgets for all ten of the Community Facilities Districts. Property tax rates are levied for operations and maintenance and general obligation debt expenditures. He presented the actual property tax rates and the projected property tax levy for each of the districts.

When housing values dropped during the recession, the value dropped, but we needed to levy the same amount of tax. The rate had to increase to accomplish this. No additional General Obligation debt was issued in any of the CFD's during this time frame. In order to levy the same amount of money, the rate needs to be raised to get the same amount of tax dollars.

The reason that there is a positive change in assessed value in Estrella Mountain Ranch (EMR) and areas north of I-10 is because new construction growth in those areas helped keep that percentage from becoming negative.

# **District Discussion:**

>Will the King Ranch CFD ever go away? Lange responded that it doesn't go away. The property was never developed. There are provisions in the statutes that allow for the dissolution of a CFD. We may meet with the property owner over the next year to see if they want to keep it or not.

>Did the assessed value rate go up because the value of the homes went down? Lange responded that the values did not go down. The method of computing the values changed under Proposition 117. Prior to Proposition 117, there was a primary and a secondary assessed valuation. The secondary valuation was ten percent of the full cash value. That has now changed, and each house can only go up so much in value.

>Is it true that property values will be capped at 5%? Lange responded that the math isn't simple. A limited property value is not the full cash value. It is true that we will not go over 5%.

>Will we consider refinancing Wildflower Ranch in the future? Lange responded that he doesn't think that we would ever be able to refinance the smaller CFD's and recover the reissuance cost.

>Would it be possible to combine some of the smaller CFD's in order to refinance for a better rate? Jim Giel, Bond Counsel representing Gust Rosenfeld, stated that this wouldn't be possible without conducting an election with the land owners of the Districts to do some sort of a consolidation. That isn't likely to happen. Lange asked if it would be possible to combine financing within the Districts for some sort of efficiency scale to pool the bonds. Giel stated that this would be a question to ask the bond financial advisor, Larry Given. Doing a pooled refinancing with multiple series may make sense. Lange will consult with Larry Given to see if

this is possible.
