Recreation Manager David Seid updated Council on the National Kids to Parks Day Program, which will be held Saturday, May 16, 2015, at the Goodyear Community Park. This is the fifth annual initiative that encourages children and families to reconnect with parks, nature, and healthy outdoor play. Activities will include traditional games, relay races, pipeline, crafts and

art projects. Staff will share information on all eighteen Goodyear parks, the upcoming summer program, aquatic program, and sports information. Vice Mayor Pizzillo read the National Kids to Parks Day Proclamation.

SPECIAL USE PERMIT FOR THE INTERO MONTESSORI SCHOOL

Planner I Alex Lestinsky presented. The item is a request by Larson Architect and Intero Montessori School for a Special Use Permit for a school at the northwest corner of Sarival Avenue and Van Buren Street in the Canyon Trails Planned Area Development. The school will be developed on 3 1/2 acres and will house up to 200 students. There will be two access points to the school, one from Van Buren Street, and one from Sarival Avenue, so there will be no excess traffic impacting the local neighborhood streets. Walls will separate the school and the outdoor fields to eliminate pedestrian access and provide safety barriers. The sports field behind the school will be lit; however, the outdoor lighting is stipulated to be screened to prevent lighting intrusion from impacting the residential use. Events taking place on the sports field should wrap up at about 8:00 p.m. Public hearing notices were satisfied, and no comments were received. The Planning and Zoning Commission approved the item during the April 15, 2015 meeting.

A Clarification Agreement has been added to clarify Stipulation No. 7 relating to right-of-way improvement along the Sarival Avenue and the Van Buren Street frontage.

Council Discussion

Where are the entrances going to be? One entrance will be on Van Buren Street and one on Sarival Avenue. Staff will be requesting a traffic impact analysis as part of the design.

Do we know what is planned for the rest of the area? James Larson of Larson Architect, indicated the site plan is strictly conceptual.

How are we going to handle traffic patterns and the possible need for a light? Engineering Director Rebecca Zook indicated it cannot be determined at this point if a signal will be required without looking at numbers, cross-traffic, and the other projects pending in the area.

What is the time frame for the intersection of Sarival Avenue and Van Buren Street? Sarival Avenue is being proposed in the FY16 budget, as is the Van Buren Street design. Van Buren Street construction is proposed in FY18. Mr Larson clarified that the parents drive in the children sometime during the day starting at 6:30 a.m. to 10:30 a.m., and pick up in the afternoon from 3:30 p.m. until approximately 7:00 p.m.

Is it normal for Council to be asked to approve a project when all of the information is not yet available? Interim Planning Manager Katie Wilken indicated a traffic study is typically required for a Special Use Permit. Because staff was trying to work with the short time frame, Engineering, Planning, and the applicant discussed during the pre-application meeting the merits of a traffic study with a Special Use Permit. Staff decided they could look at the information with the site plan instead. This was decided mostly because of the number of students, and the fact that the drop off mechanism wasn't dissimilar from that of a day care, which is a Permitted Use in a C-2 zone. Staff didn't see that there was an extraordinary change to the circulation pattern, and felt comfortable bringing the item to Council.

Does the Clarification Agreement clearly stipulate a requirement for a traffic study? Stipulation No. 3 states that a traffic impact analysis still needs to be submitted, that might generate additional requirements.

**CODE-SPECIAL EVENTS AND AMENDMENT OF MUNICIPAL
USER FEE SCHEDULE**

City Clerk Maureen Scott presented. Scott provided background on the responses received from public outreach that was conducted, from staff members and council members during the Ordinance suspension. The amendment will eliminate regulations on certain types of events and amend other provisions in the Ordinance that have a deterrent impact on community events and gatherings.

Proposed changes

Apply to any outdoor event that has more than 250 people, rather than 50 people
Eliminate the amplified sound criteria
Eliminate the Special Event Application Fee
Revision to the insurance requirement
Application deadlines
Fee waivers for neighborhood events sponsored by public schools and/or 501(c)(3)
Block Parties - eliminate the requirement that consent from each resident affected by the street closure be obtained, eliminate the requirement that only City approved traffic barricades be used to close off streets, and eliminate the insurance requirement

Council Discussion

. **Support for 501(c)(3) but not for the 501(c)(6) organizations.**
. **Would the Chamber of Commerce have needed a Special Event Permit to hold the Goodyear For Growth event?** Since the event was held in the PebbleCreek Tuscany Ballroom, there would not have been a permit requirement because the Tuscany Ballroom is zoned for that use.
. **Provide clarification on the 501(c)(3) public school fee waiver.** Assistant City Attorney Sarah Chilton responded that the Ordinance includes waivers for public schools **and** 501(c)(3) organizations.
