## **RECOMMENDATION:**

Approve a request from Andrea Lewkowitz, agent/applicant for MOD Super Fast Pizza, LLC, doing business as MOD Pizza, for a new Series 12 liquor license #1207A213, located at 1380 North Litchfield Road, Suite K-3A, Goodyear, Arizona 85395 (generally located on the west side of Litchfield Road, North of I-10 and South of McDowell Road).

## **PURPOSE:**

Ms. Lewkowitz has applied for a new Series 12 (Restaurant) liquor license #1207A213 on behalf of MOD Super Fast Pizza. MOD Pizza opened for business last month and is currently operating under an interim liquor license. The applicant has paid the \$635.00 fee.

# BACKGROUND AND COMMUNITY BENEFIT:

The Office of the City Clerk received this application on March 30, 2015. MOD Pizza is a privately-owned company based in Washington State, with approximately forty restaurants in nine states. This will be its third location in Arizona.

This application was originally scheduled to be heard during a public hearing scheduled at the May 18, 2015 City Council meeting. On that date, the applicant requested that it be moved to the June 22, 2015 Council meeting because of a recent change in the applicant's ownership structure. Continuing the application would enable staff time to review and conduct an investigation of the additional "controlling person".

State law (ARS 4-201) requires that the local governing body recommend approval or disapproval within sixty days after filing of the application. Due to this change to the ownership structure, the applicant has waived this requirement.

Ms. Lewkowitz is the agent in an administrative capacity only and does not hold any interest in the day-to-day operations of this business.

Until this liquor license is issued by the Arizona Department of Liquor Licenses and Control, MOD Pizza is allowed to sell alcohol as permitted through the interim permit process. An interim permit, as defined in ARS 4-203.01, is a conditional permit and authorizes the holder to sell alcoholic beverages that would be permitted to be sold under the privileges of the license for which the application has been filed. An interim permit, which will expire on July 8, 2015, has been issued to the applicant.

Staff has been informed that there will be a manager who is certified in the sale of alcohol on site at all times, and staff will be trained in responsible alcohol sales and service. All guests who appear to be under 35 years of age will be required to show valid I.D.

A Series 12 License is for a restaurant and is non-transferable. It allows the holder of the license to sell and serve all types of spirituous liquor solely for consumption on the premises of an establishment which derives at least forty percent of its gross revenue from the sale of food.

There are no licensed childcare facilities within 300 ft. of the location.

The application has been properly reposted for the State mandated 20-day period. Any petitions or protests pursuant to A.R.S. 4-201(b) received during the 20-day posting period will be added to this report. The applicant has submitted the proper paperwork. There is no information at this time that would prohibit the applicant from obtaining this license.

The City Council's recommendation of approval, disapproval or no recommendation will be forwarded to the Department of Liquor Licenses and Control ("Department") for their consideration. If the City Council recommendation is for approval, no hearing is required unless the Director of the Department, the State Liquor Board ("Board"), or any aggrieved party requests a hearing on the grounds that the public convenience and the best interest of the community will not be substantially served if a license is issued. If no hearing is requested, the Director may approve the license. If the City Council recommendation is for disapproval of an application, a statement of the specific reasons along with a summary of the testimony or other evidence supporting the recommendation for disapproval shall be attached to the order of disapproval and submitted to the Director and a public hearing will be held.

If the City Council recommendation is no recommendation, the Director may cancel the hearing and issue the license unless the Board, or any aggrieved party, protests and requests a hearing. If the reason for the protest is clearly removed or deemed satisfied by the Director, the Board shall cancel the hearing and the Department may issue the license. The application has been routed to Police, Fire, Code Enforcement, and Community Development. (Attachment A)

The completed application is on file in the office of the City Clerk.

# FISCAL ANALYSIS:

The applicant initially paid a \$635.00 application fee per the Goodyear Municipal User Fee Schedule, and has paid an additional \$70.48 for reposting the public hearing. This business will contribute to the tax base of the community.
