RESOLUTION NO. 15-1712

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA AUTHORIZING THE ESTABLISHMENT OF A PUBLIC STREET TO BE CONSTRUCTED, OPENED AND MAINTAINED BY THE CITY; REQUIRING RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant the power vested in the City of Goodyear ("City") by its Charter and pursuant to A.R.S. § 9-276, the Mayor and Council of the City of Goodyear have the power to establish, construct, improve, regulate vacate, modify roadways open to the public; and

WHEREAS, the City owns two parcels of real property consisting of a total of approximately 10 acres (City 911 Communication Facility and Police Department Operations Facility Sites) located southeast of Van Buren Street and 145th Avenue. (the "PD Facilities Parcels"); and

WHEREAS, pursuant to the design and anticipated construction of the Police Department Operations Facility ("Operations Facility"), the City is in the process of designing the associated infrastructure which includes the extension of 145th Avenue; and

WHEREAS, The easterly half-street location for 145th Avenue was included in the purchases of the 911 Communication Facility site (which was part of the acquisition of the Goodyear Municipal Complex) and the recent purchase of the Police Department Operations Facility Site; and

WHEREAS, the City has not platted the PD Facilities Parcels and has not established the 145th Avenue alignment where the 145th Avenue half-street improvements are to be constructed as a public road; and

WHEREAS, the Mayor and Council of the City of Goodyear find and determine that the public health, safety, and welfare require the establishment of a public street in the alignment more particularly described in the legal description, attached hereto as Exhibit A, to be opened to the public and maintained by the City.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Goodyear, Maricopa County, Arizona, as follows:

The Mayor and Council of the City of Goodyear find and determine that it is in the interest of the public health, safety and welfare of the City to designate and hereby declare as a public street that portion of the PD Facilities Parcels, more particularly described and depicted in the Exhibit A attached hereto, and by reference, made a part hereof.

Section 2.	The City Clerk shall cause a certified copy of this Resolution, including Exhibit A, attested by the City Clerk, to be recorded in the official records of the Maricopa County Recorder.				
Section 3.	That this Resolution shall become effective upon its adoption.

THENCE SOUTH 00 DEGREES 07 MINUTES 55 SECONDS EAST, 536.55 FEET;


