A RESOLUTION OF THE GOODYEAR VOLUNTEER AND RESERVE FIREFIGHTER RETIREMENT TRUST BOARD ALLOCATING UNALLOCATED BALANCES OF THE FUND AND GIVING DIRECTION TO THE INNES ASSOCIATES, LTD. REGARDING ALLOCATIONS.

WHEREAS, in accordance with the provisions of Title 9, Chapter 8 of the Arizona Revised Statutes (A.R.S.), the Goodyear Volunteer and Reserve Firefighter Retirement Trust was established in 1990 to provide an alternative pension and benefit program for volunteer and reserve firefighters; and

WHEREAS, a Board of Trustees of the Goodyear Volunteer and Reserve Firefighter Retirement ("Board") was established per A.R.S. §9-954 as the Goodyear Volunteer and Reserve Firefighter Retirement Trust Advisory Committee (referred to as both the "Board" and the "Committee") and shall provide for the disbursement of the fund and designate the beneficiaries of the fund as directed; and

WHEREAS, there are currently six individuals vested in the Goodyear Volunteer and Reserve Firefighter Retirement Trust; and

WHEREAS, there are unallocated funds in the Goodyear Volunteer and Reserve Firefighter Retirement Trust of \$130,248.67 to be allocated; and

WHEREAS, the Innes Associates, Ltd. has calculated four different methods for allocation, all of which have been reviewed by this Board.

NOW, THEREFORE, BE IT RESOLVED BY THE GOODYEAR VOLUNTEER AND RESERVE FIREFIGHTER RETIREMENT TRUST ADVISORY COMMITTEE, AS FOLLOWS:

That the unallocated balances in the Goodyear Volunteer and Reserve Firefighter Retirement Trust be allocated as shown in Exhibit A.
