## **RESOLUTION NO. 15-1720**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF GOODYEAR AND THE CITY OF LITCHFIELD PARK FOR FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The City of Litchfield Park does not provide municipal fire services and recognizes that the creation of a municipal fire service is cost prohibitive; and

WHEREAS, The City of Litchfield Park desires to provide its citizens municipal fire protection in a cost effective manner; and

WHEREAS, The City of Litchfield Park and the City of Goodyear entered into a fire protection assistance and emergency medical services agreement on June 14, 2010 (Resolution 10-1373); and

WHEREAS, The City of Litchfield Park and the City of Goodyear have mutually agreed to the proposed Amendment to the Intergovernmental Agreement for Fire Protection and Emergency Medical Services;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, ARIZONA, AS FOLLOWS:

SECTION 1. The Mayor and Council approve the Amendment to the Intergovernmental Agreement and grant the City Manager authority to sign the Amendment.

SECTION 2. The Amendment to the Intergovernmental Agreement shall become effective after it is (i) approved by the respective City Councils, and (ii) executed by both Parties.
