B. WHEREAS the purpose of Sewer Easement was for the operation, maintenance, repair, and replacement of an underground sewer line and associated facilities within the property legally described in Exhibit A and depicted in Exhibit B to the Sewer Easement (the "Easement Property"); and

C. WHEREAS, the City has determined that portions of the Easement Property are no longer needed; and
