RESOLUTION NO. 15-1729

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE MAYOR TO ADOPT A MULTI-JURISDICTIONAL MULTI-HAZARD MITIGATION PLAN FOR THE REDUCTION OF HAZARD RISK TO THE COMMUNITY.

WHEREAS, the 2015 Maricopa County Multi-Jurisdictional Multi-Hazard Mitigation Plan (the Plan) has been developed after more than one year of review, research and update work by the City of Goodyear in association and cooperation with the Maricopa County Multi-Jurisdictional Planning Team for the reduction of hazard risk to the community; and

WHEREAS, the Plan specifically addresses natural hazard vulnerabilities, mitigation strategies and plan maintenance procedures for the City of Goodyear;

WHEREAS, the Plan is an update and replacement for the previous hazard mitigation plan for the City of Goodyear; and

WHEREAS, the Plan recommends several hazard mitigation actions/projects that will provide mitigation for specific natural hazards that impact the City of Goodyear, with the effect of protecting people and property from loss associated with those hazards;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, ARIZONA, AS FOLLOWS:

SECTION 1. The Plan is hereby adopted as an official plan of the City of Goodyear.

SECTION 2. The Plan shall be implemented, monitored and maintained by the officials/staff designated in the Plan for a period of five (5) years with the full support of this resolution.
