1. CALL TO ORDER

Chairman Lord called the Community Facilities District Special Joint Meeting to order at 5:30 p.m.

6. BUSINESS

Interim Finance Director Chuck Odom presented the ten tentative budgets and approximate tax rates. He reviewed the schedules for Operations and Maintenance (O&M), Debt Service, Approximate Property Tax Rates, and Preliminary Limited Property Value (LPV). The property tax rates are levied for O&M and for general obligation debt expenses. Odom indicated that there has been an increase in the property tax levy over the prior fiscal year for all Community Facilities Districts (CFDs), except for King Ranch, due to declining assessed value. The property tax rates are at the targeted rate except for Community Facilities Utility District (CFUD)#1, Wildflower Ranch CFD, Wildflower Ranch CFD#2, and Cottonflower CFD, which are slightly above the targeted rates. We have a deficiency agreement with Estrella Mountain Ranch CFD, which requires them to pay the amount above their tax rate to keep it at the targeted amount. CFUD#1 will close on the refinance of their debt on May 25 for a savings of approximately \$2.5 million. The Final CFD Budget adoption and the adoption of the CFD Tax Levies is scheduled on June 27.

Board Discussion:

> **Would like clarification that we are not seeing the refinancing of some of the bonds within these schedules.** Odom indicated that the only authorization to refinance is for CFUD#1.

> **Noticed there are some deficiencies and that the fund balance helps take care of that. Concerned with next year's projection because it does not look like the fund balance will accommodate those deficiencies.** Odom said that the CFD's that have deficiency agreements are below their assessed value. For the CFD's that do not have deficiency agreements, the deficiency falls to the rate payer to make up the shortfall.

> **Can King Ranch use the tax rate as a marketing tool?** District Manager Brian Dalke indicated that King Ranch is in the hands of Elman Companies, and they have asked questions as to what their obligations are under the current development agreements. Nothing else has been done at this point. Dalke said that CFD's are a tool to put in public infrastructure and would be financed with general obligation bonds versus a special assessment.

> **A bigger challenge for King Ranch is finding a way to come up with monies owed to the city, and we need to keep this in mind when talking to them about development.** Dalke

indicated the amount owed is almost double the original principal amount.
