Revisions to Tentative



Total Budget Remains - \$254 Million

- Council approved:
 - Community Paramedicine - \$125,000, Grant
 - Public Safety LTD Gap - \$28,000, General Fund
 - Technical revisions:
 - Planned capital replacements per team agreements- \$415,000; Stadium
 - Finalize Container Maintenance budget – (\$219,204), Sanitation
 - Contract reduction - \$700,000
 - Container program FY17 base budget is \$563,564 includes position and other base budget items funded in FY16)
- Offset: CIP-Potential Improvement District (appropriation contingency)– \$(348,796)



Truth In Taxation – Primary Property Tax

An Ongoing General Fund Revenue

- State Constitution limits annual increase to no more than 2%
- State Statute requires Truth In Taxation process to increase levy by any amount
- Truth in Taxation amount for FY17 - \$161,291

<i>FY17 without 2% and without New Properties – Truth In Taxation Level, Same Levy Amount</i>	<i>\$1.1371</i>	<i>\$7,807,747</i>
FY17 (2% growth and New Properties) as included in Final Budget	\$1.1598	\$8,240,777

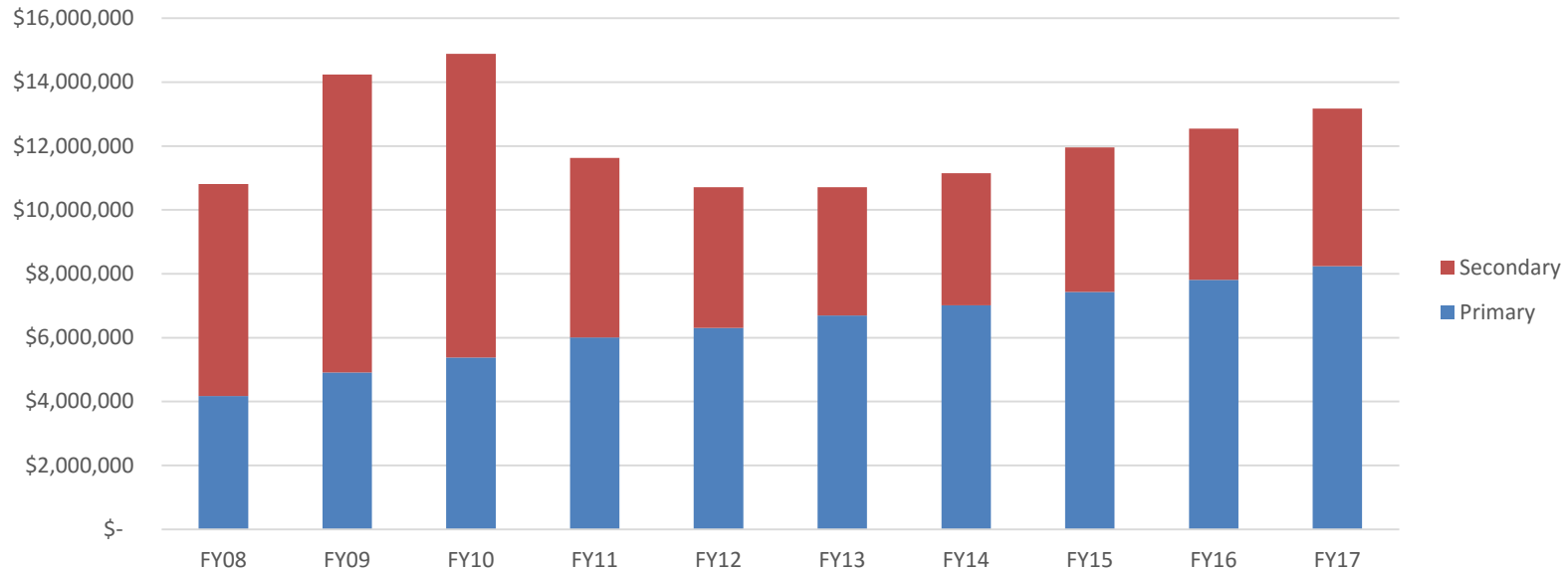

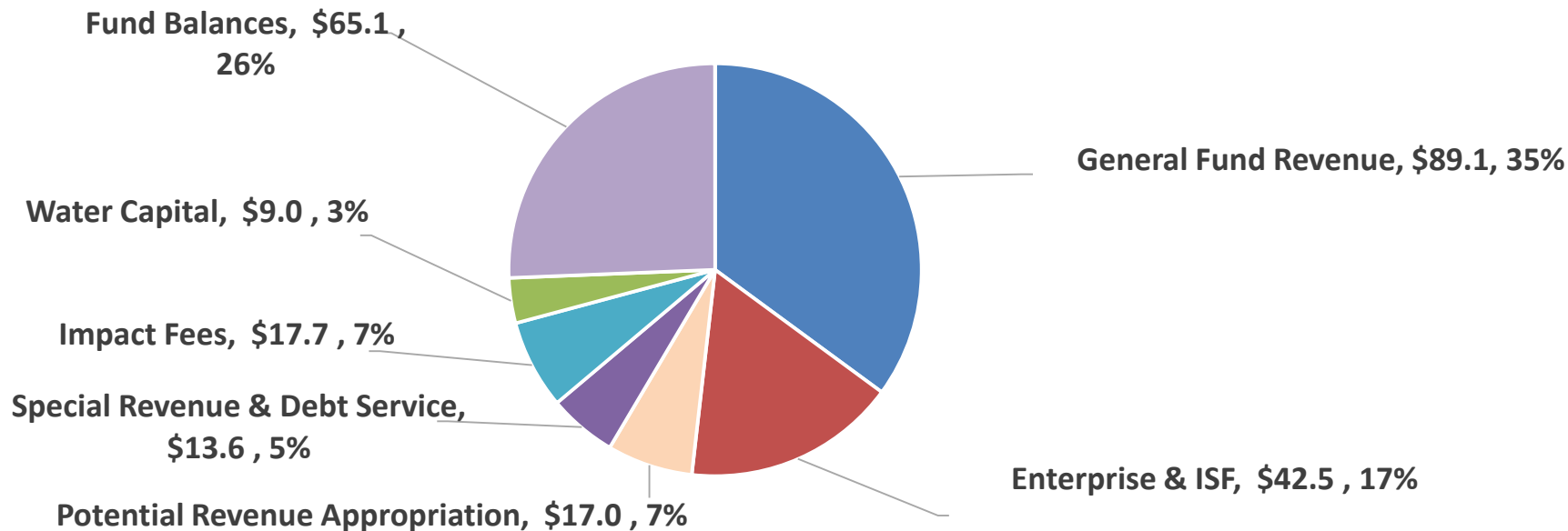
Historical Combined Property Tax Levy



All Funds FY17 Resources - \$254 Million



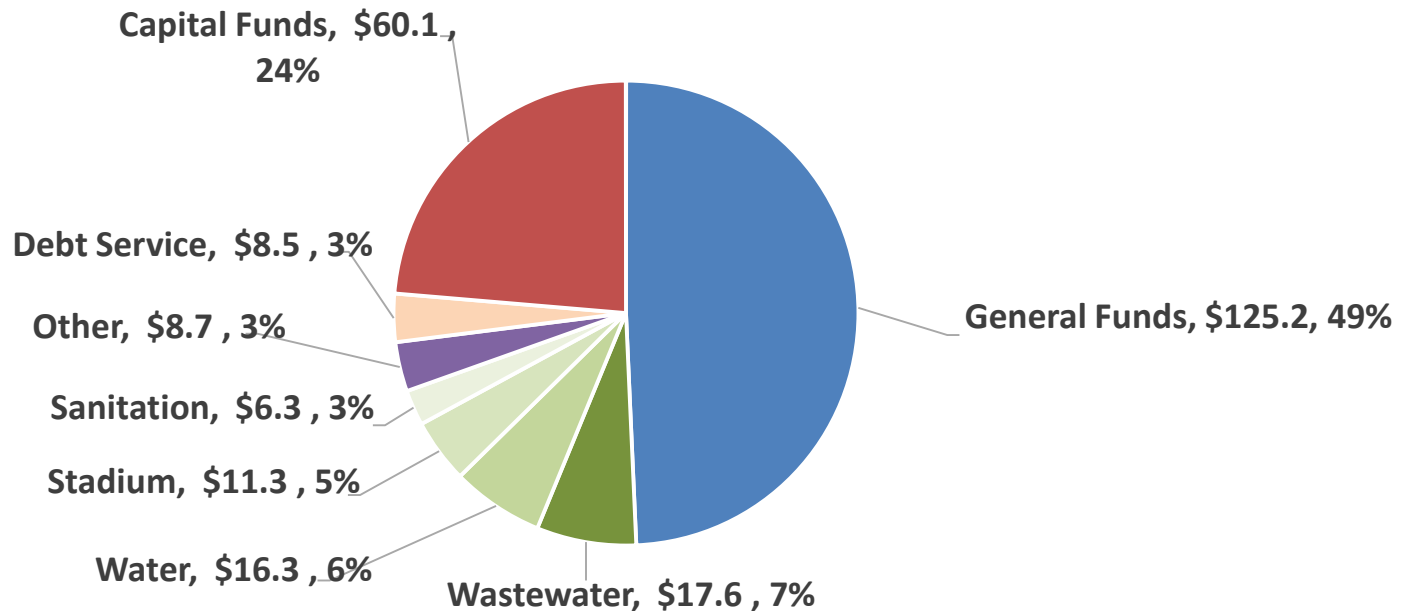

All Funds FY17 Budgeted Expenditures by Fund - \$254 Million



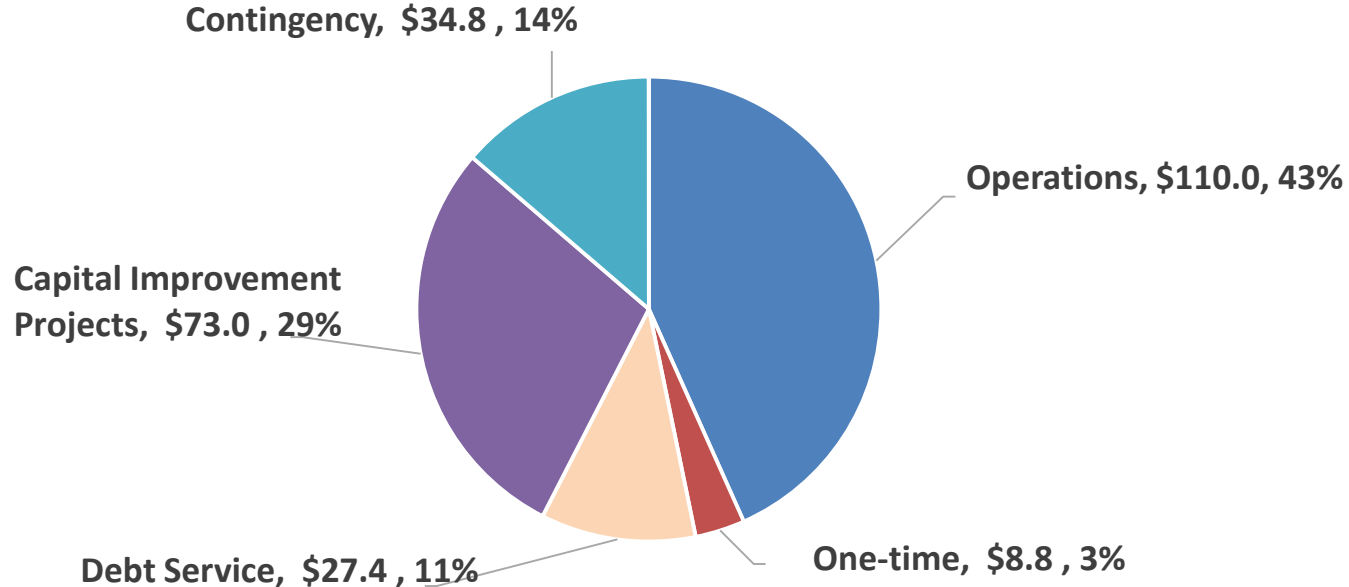

All Funds FY17 Budget Expenditures by Type - \$254 Million



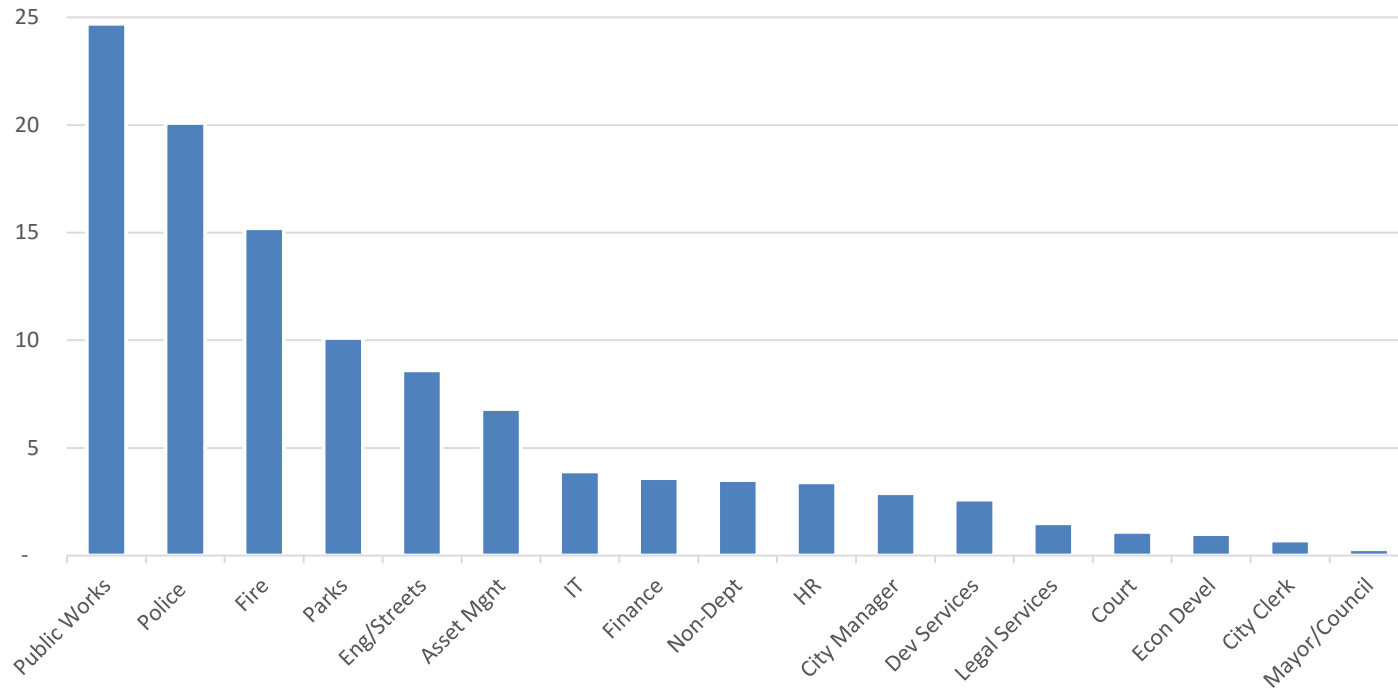

FY17 Operations Base Budget by Department - \$110M



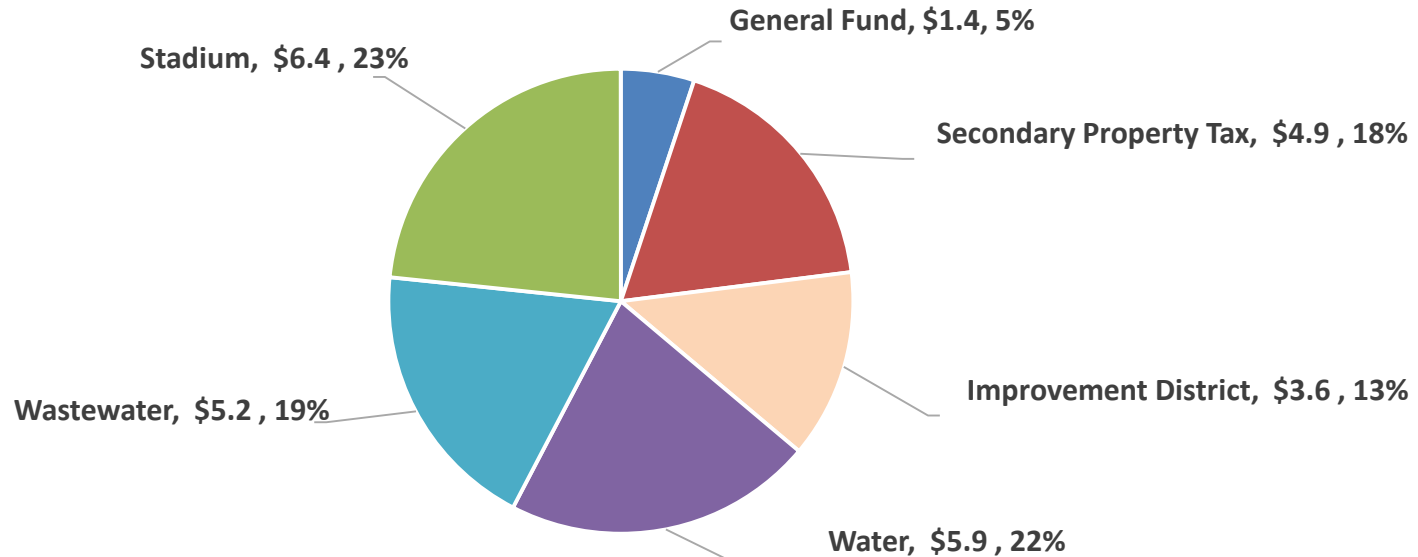

FY17 Debt Service By Fund - \$27.4M



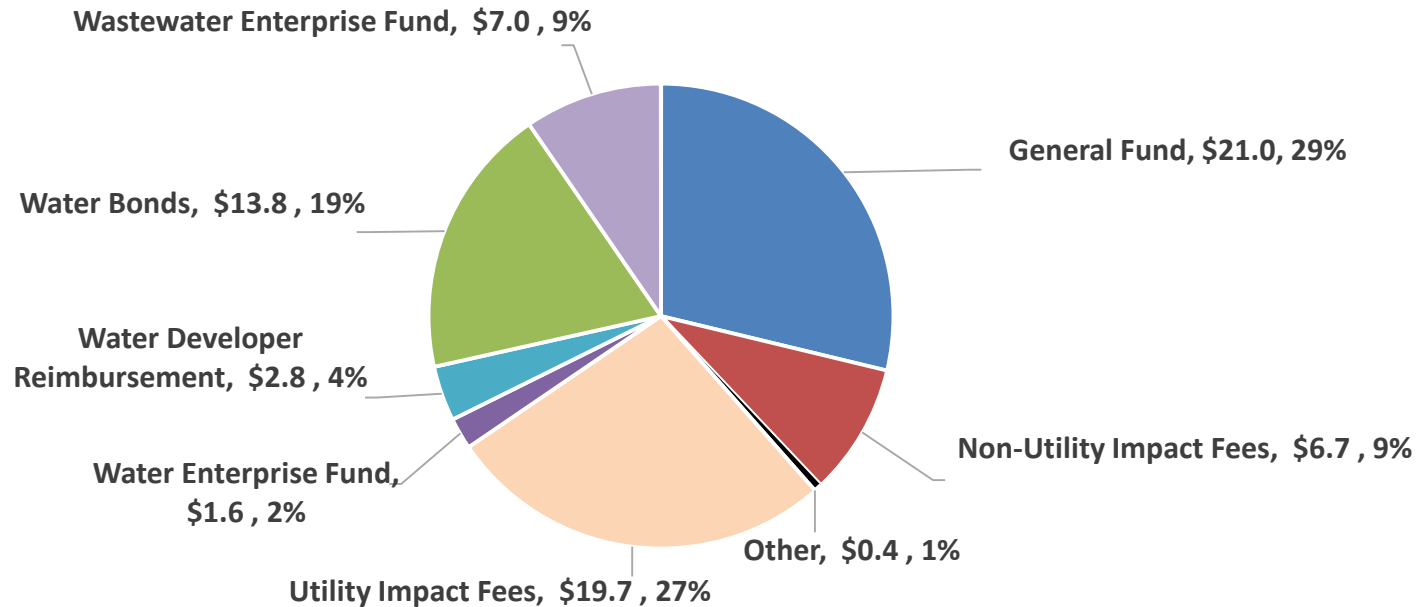
