RECOMMENDATION:

- 1. Approve a request from Troy Charles DeVos, agent for QuikTrip Corporation, dba QuikTrip #446, for an Acquisition of Control for Series 10 Liquor License #10074069, located at 550 N. Dysart Road, Goodyear, Arizona (Generally located north of the intersection of Dysart Road and Van Buren Street); and
- 2. Approve a request from Troy Charles DeVos, agent for QuikTrip Corporation, dba QuikTrip #1401, for an Acquisition of Control for Series 10 Liquor License #10075880, located at 575 N. Estrella Parkway, Goodyear, Arizona (Generally located on the east side of Estrella Parkway south of the I-10 interchange).

PURPOSE:

QuikTrip recently had a change in their ownership structure. Therefore, they are required to apply for an Acquisition of Control with the Arizona Department of Liquor Licenses and Control.

BACKGROUND AND PREVIOUS ACTIONS:

Quick Trip #446 was issued a Series 10 Liquor License #10074069 on April 11, 2001.

QuikTrip #1401 was issued a Series 10 Liquor License #10075880 on September 28, 2010.

A Series 10 Liquor License is for a beer and wine store and is non-transferable.

The completed applications for Acquisition of Control is on file in the City Clerk's Office.

These types of liquor license applications have previously not been taken to Council for consideration in Goodyear. In the fall of 2015, the Arizona Department of Liquor Licenses and Control provided training advising cities that the Local Governing Body (City Council) should be making a recommendation to the Liquor Board on Acquisition of Control applications, and to also post the property with a Notice of Hearing for 20 days prior to the scheduled City Council meeting date. Going forward, these applications will be placed on the Consent agenda for Council consideration.

CURRENT POLICY:

A.R.S. §4-203: Licenses: issuance: transfer: reversion to state

F. If a person other than those persons originally licensed acquires control over a license or licensee, the person shall file notice of the acquisition with the director within thirty business days after the acquisition of control and a list of officers, directors or other controlling persons on a form prescribed by the director. All officers, directors or other controlling persons shall meet the qualifications for licensure as prescribed by this title. On request, the director shall conduct a pre-investigation before the assignment, sale or transfer of control of a license or licensee, the reasonable costs of which, not to exceed one thousand dollars, shall be borne by the applicant. The pre-investigation shall determine whether the qualifications for licensure as prescribed by this title are met. On receipt of notice of an acquisition of control or request of a pre-investigation, the director shall forward the notice within fifteen days to the local governing body of the city or town,

If the licensed premises is in an incorporated area, or the county, if the licensed premises is in an unincorporated area. The local governing body of the city, town or county may protest the acquisition of control within sixty days based on the capability, reliability and qualification of the person acquiring control. If the director does not receive any protests, the director may protest the acquisition of control or approve the acquisition of control based on the capability, reliability and qualification of the person acquiring control. Any protest shall be set for a hearing before the board.

Any transfer shall be approved or disapproved within one hundred five days of the filing of the notice of acquisition of control. The person who has acquired control of a license or licensee has the burden of an original application at the hearing, and the board shall make its determination pursuant to section 4 202 and this section with respect to capability, reliability and qualification.

- H. A restructuring of a licensee's business is an acquisition of control pursuant to subsection F of this section and is a transfer of a spirituous liquor license and not the issuance of a new spirituous liquor license if both of the following apply:
- 1. All of the controlling persons of the licensee and the new business entity are identical.
- 2. There is no change in control or beneficial ownership.

The City Council's recommendation of approval, disapproval or no recommendation will be forwarded to the Department of Liquor Licenses and Control ("Department") for their consideration. If the City Council recommendation is for approval, no hearing is required unless the Director of the Department, the State Liquor Board ("Board"), or any aggrieved party requests a hearing on the grounds that the public convenience and the best interest of the community will not be substantially served if a license is issued. If no hearing is requested, the Director may approve the license. If the City Council recommendation is for disapproval of an application, a statement of the specific reasons along with a summary of the testimony or other

evidence supporting the recommendation for disapproval shall be attached to the order of disapproval and submitted to the Director and a public hearing will be held.

If the City Council recommendation is no recommendation, the Director may cancel the hearing and issue the license unless the Board, or any aggrieved party, protests and requests a hearing. If the reason for the protest is clearly removed or deemed satisfied by the Director, the Board shall cancel the hearing and the Department may issue the license.

PUBLIC PARTICIPATION:

The application has been properly posted on the property for the State mandated 20-day period. Any petitions or protests pursuant to A.R.S. 4-201(b) received during the 20-day posting period will be added to this report.

STAFF ANALYSIS:

There are no licensed childcare facilities or K-12 schools within 300 ft. of the location.

The application has been routed to Police, Fire, Code Enforcement, and Community Development, and any comments are listed on Attachment A.

FISCAL ANALYSIS:

Per the Goodyear Municipal User Fee Schedule, a liquor license fee is only charged for new liquor licenses. Acquisition of Control Liquor Licenses are current liquor licenses, therefore, no fee is charged.


