

RESOLUTION NO. 16-1755

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AMENDING THE MUNICIPAL USER FEE SCHEDULE ADOPTED BY RESOLUTION NO. 10-1357 BY ADDING STREET CLOSURE FEES THAT WERE LISTED IN ORDINANCE NO. 2000-698, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Resolution No. 10-1357 approved and adopted a document entitled Goodyear Municipal User Fee Schedule; and

WHEREAS, Ordinance No. 2000-698 adopted street closure fees; and

WHEREAS, after reviewing Ordinance No. 2000-698 that listed street closure fees, it was decided that the fees should be listed in the User Fee Schedule instead of a separate ordinance; and

WHEREAS, Exhibit A attached hereto shows the Street Closure Fees that are to be added to the Municipal User Fee Schedule;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The Municipal User Fee Schedule adopted by Resolution 10-1357 is hereby amended to add the Street Closure Fees reflected in Exhibit A attached hereto.

SECTION 2. This resolution shall be effective at the time and in the manner prescribed by law.
