5.4. Review 2015 Monthly Financial Statements

Item 5.3. and 5.4. were presented together.

Finance Director Doug Sandstrom reviewed the allocation of the Suspense Account and current financial status for the board. He explained how to review the individualized statements. The annual individual statements will identify each allocation. The monthly statement from January 2016 showed a loss of \$20,000. The amount has since recovered and there is now \$405,000 in the fund as of June 2016 which is an increase of approximately \$1,500.00 for the calendar year. Sandstrom explained how to identify the mutual funds the account is invested

in.

Sandstrom said only the Board of Trustees will work directly with Innes Associates instead of the city of Goodyear Finance Department from now on. The statements arrive on a monthly basis and the City Clerk's Office will distribute them to the three boardmembers, Jay Mathias, Guy Farris, and Robert Manning. Other members that have money in the fund can contact the Board of Trustees directly for the information.

5.5. Review of Allocation of the Suspense Account and Current Financial Status

5.6. Appointment/Removal of Authorized Trustees on Investment Account

Management Assistant Lisa Neagle said there is \$14.73 with LPL Financial Services that needs to be sent to Innes Associates. Previous Fire Chief Mark Gaillard and previous Finance Director Larry Price's name's are still on the documents. Neagle spoke to Gaillard, and he will forward the check to Innes Associates so the check can be deposited into the fund.
