#### **RECOMMENDATION:**

Approve a request from Andrea Dahlman Lewkowitz, agent for Harkins Estrella Falls, LLC, for a Series 6 Person Transfer/Location Transfer Liquor License #06070129, located at 15010 West McDowell Road, Goodyear, Arizona 85395 (generally located near the northeast corner of McDowell Road and North 150<sup>th</sup> Drive).

#### **PURPOSE:**

Ms. Lewkowitz has applied for a Person Transfer/Location Transfer Series 6 (Bar) Liquor License #06070129 with the Arizona Department of Liquor Licenses and Control. Harkins Theaters anticipates opening this new location in October, 2016.

# **BACKGROUND AND PREVIOUS ACTIONS:**

The City Clerk's Office received this application from the Department of Liquor Licenses and Control on September 14<sup>th</sup>. The agent on the application at that time was Clare Hollie Abel. We received an Amendment from the Arizona Department of Liquor Licenses and Control on September 30, 2016, changing the agent to Andrea Dahlman Lewkowitz. Harkins Theaters is not a franchise.

Harkins Theaters is a family owned and operated business, founded and based in Arizona since 1933. With 30 locations in five states, Harkins Theatres is the 5th largest theater circuit in North America.

Harkins currently has a location that sells liquor at Camelview Plaza in Scottsdale. They are also applying with the City of Chandler to sell liquor at the Chandler Crossroads location.

#### **CURRENT POLICY:**

A Series 6 License is a "Bar license", and means authorization issued to an on-sale retailer to sell:

a. Spirituous liquors in individual portions for consumption on the licensed premises; b. Spirituous liquors in an original, unopened, container for consumption off the licensed premises provided sales for consumption off the licensed premises, by total retail sales of spirituous liquor at the licensed premises, are no more than the percentage of the sales price of on-sale spirituous liquor established under A.R.S. § 4-206.01(F); and c. Beer in a clean glass container that is sealed and labeled as described in A.R.S. § 4-244(32). A person transfer license includes partnerships, associations, limited liability companies or corporations, as well as a natural person. ARS § 4-101(25).

A location transfer is the application process for moving a license from one premises to another within the same county. ARS § 4-203.

The City Council's recommendation of approval, disapproval or no recommendation will be forwarded to the Department of Liquor Licenses and Control ("Department") for their consideration. If the City Council recommendation is for approval, no hearing is required unless the Director of the Department, the State Liquor Board ("Board"), or any aggrieved party requests a hearing on the grounds that the public convenience and the best interest of the community will not be substantially served if a license is issued. If no hearing is requested, the Director may approve the license. If the City Council recommendation is for disapproval of an application, a statement of the specific reasons along with a summary of the testimony or other evidence supporting the recommendation for disapproval shall be attached to the order of disapproval and submitted to the Director and a public hearing will be held.

If the City Council recommendation is no recommendation, the Director may cancel the hearing and issue the license unless the Board, or any aggrieved party, protests and requests a hearing. If the reason for the protest is clearly removed or deemed satisfied by the Director, the Board shall cancel the hearing and the Department may issue the license.

# **PUBLIC PARTICIPATION:**

The application has been properly posted on the property for the State mandated 20-day period. Any petitions or protests pursuant to ARS § 4-201(b) received during the 20-day posting period will be added to this report.

# **STAFF ANALYSIS:**

The applicant informed staff that there will be a manager who is certified in the sale of alcohol on site at all times, and staff will be trained in responsible alcohol sales and service.

There are no licensed childcare facilities or K-12 schools within 300 ft. of the location.

The application has been routed to Police, Fire, Code Enforcement, and Community Development, and any comments are listed on Attachment A. The completed application is on file in the City Clerk's Office.

# FISCAL ANALYSIS:

The applicant has paid the \$635.00 application fee per the Goodyear Municipal User Fee Schedule. This business will contribute to the tax base of the community.
