#### 5. OLD BUSINESS

### 5.1 Fee Philosophy Discussion and Exercise

Parks and Recreation Manager David Seid gave an overview of recent fee and cost recovery research for parks and recreation services provided to the community as well as individuals. This research included looking at peer cities and what are the best practices and trends related to cost recovery and revenue generation, and where does our current practice fit. Seid mentioned that our current fee philosophy was passed back in 2010 and that the city is due for review. He explained the fee philosophy exercise and the input needed from the Commissioners on several parks and recreation services and their cost recovery, in relation to their benefit to the community. He introduced Parks and Recreation Intern Blaise Caudill who listed the various services that Parks and Recreation provides to the community and gave examples of how the services might fit in a particular category. Recreation Superintendent Mike Beadle also assisted with this activity. Commissioners' input was solicited and encouraged in assigning parks and recreation services to the following categories:

- Exclusively Individual
- Highly Individual
- Individual / Community
- Community / Individual
- Community

After review and discussion of the various services provided by Parks and Recreation, the Commissioners assigned each of the various services to the categories as follows:
