6.2 Logo 101 Presentation from Sarna O'Brien, Graphic Designer for the city of Goodyear

Graphic Designer Sarna O'Brien introduced herself and touched on her background experience. She spoke about the logo being a representation of what the public should know about the organization it represents. She provided examples of popular logos that have been upgraded with time and other examples from groups within the city. O'Brien then lead discussions on what the Youth Commission's logo should look like from the Youth Commissioners viewpoints.

6.3 Discussion and Vote of Possible Youth Commission Logo Design and Creation

No action was taken, but there was discussion of shaking hands, social media, lettering with arrows, and specific key words, such as leadership or volunteerism to be incorporated into the logo. It was agreed that this would be something that takes time. The item will be brought back to the Commission at a later date.
