# 5.4 Police Board will review Independent Medical Examination for Joshua Swain in consideration of his Accidental Disability Application.

Chairman Stipp said it is their intent to keep Swain's medical records private.

Swain said the question submitted to the IME doctor states that he was not compliant with weight lifting restrictions. During December 2015-December 2016, there were only two months that he had a weight restriction. He was instructed to increase his weight lifting.

Swain said that the requirements for a police officer should be reevaluated. It is crazy that a police officer should only lift fifty pounds. There is also a no running requirement as part of the physical test. Chairman Stipp said that the board doesn't decide city policies.

Swain said he wants to be a cop. He was told he had to make a decision and that he didn't have an option but to apply for disability. Swain asked what is the next step? Chairman Stipp said Swain would need to contact the Human Resources Department.

Chairman Stipp reviewed the eight questions on the Accidental Disability Questionnaire:

1. Did the employee file the application after the disability incident, or within one year of ceasing to be an employee? Yes

- 2. Did (or will) the employee terminate by a reason of a disability? No
- 3. Did employment terminate based on a disciplinary issue? No
- 4. If the member's period of DROP has ended, if applicable, did (or will) the employee terminate by a reason of disability? N/A

5. Is the employee still working a position within their job classification that the Local Board considers a reasonable range of duties position? Yes

6. Has the employee refused a position within their job classification that the Local Board considered a reasonable range of duties? No

7. Did the injury or condition occur prior to the current PSPRS membership date? No

8. Was the injury or condition the result of an event incurred during the performance of the employee's duty? Yes

## MOTION by Boardmember Hughes, SECONDED by Boardmember Mathias, to DENY an Accidental Disability Application for Joshua Swain. The motion carried by the following vote:

Chairman Stipp said since this application has been denied Swain will need to contact Human Resources about the next steps. Chairman Stipp told Swain that he has the ability to appeal the decision and he would need to contact the Board secretary for the appeal process.
