4. **COMMUNICATIONS**

4.1 CO-273-17 St. Mary's Food Bank Alliance will present a "Hunger Heroes" plate to the city in honor of the support the city has provided to their nonprofit organization.

Christina Plante, Neighborhood Services Coordinator, introduced David Martinez with St. Mary's Food Bank Alliance. St. Mary's Food Bank Alliance is celebrating their 50th year in

operation. Martinez thanked the city for their generous contributions to their program. They were able to provide 35,000 meals to city of Goodyear residents with last year's \$5,000 donation. He presented Council with a Hunger Heroes' Plate.

4.2 CO 274-17 Recognize the Millennium High School Art Teacher, Richard Gross, and his photo students for their accomplishment of completing the artwork currently on display at City Hall.

Lauren Valencia, Assistant to the Mayor, introduced Les Meyers with the White Tanks Nature Conservancy, Co-Chair of the Conservancy Buckeye Mayor Jackie Meck, and Co-Chair Todd Hornback. They are a diverse coalition of founding partners working to protect the White Tank Mountains. The Conservancy ensures that the White Tank Mountains remain connected to the broader region in the following ways:

- >Regional trail network.
- >Connections for recreational activities.
- >Appropriate wildlife corridors to prevent genetic isolation.

This project is a large scale regional effort. They invited the city of Goodyear to become one of the members of the White Tank Conservancy.

- 7.2 17-6056 PLANNED AREA DEVELOPMENT AMENDMENT TO AMEND THE
 WOOD CORPORATE CAMPUS AND BALLPARK VILLAGE FINAL
 PLANNED AREA DEVELOPMENT AND DESIGN GUIDELINES

Vice Mayor Lauritano opened the Public Hearing at 6:55 p.m.

Karen Craver, Planner III, presented. Ballpark Village is the Ballpark and surrounding future development parcels. The Wood Corporate Campus is home to the Indians and the Reds Development complexes, and the undeveloped property to the west of that. Craver showed the original Wood Corporate Campus. It included flex industrial complexes as well as office buildings going up to nine stories, with no residential development. Communities Southwest purchased portions of the property in 2014 and submitted a PAD Amendment last year. The primary change is from flex industrial and office to residential. Commercial and industrial to the south remain. Craver showed a proposed residential plan and amenity theme on the property across from the development complexes. The revised permitted use list includes allowing drive-thru's in Ballpark Village. Staff suggested design and location criteria for drive-thru use if Planning and Zoning chooses to allow them. Staff suggested drive-thru businesses would need to have it's primary sales being coffee, tea or other beverages.

The Planning and Zoning Commission recommended approval with a vote of 4-2. This vote was centered around a discussion of allowing drive-thru businesses. They were very supportive of the residential development.

Ed Bull, Attorney for Community Southwest, spoke in support of the PAD amendment.

There being no further public comment, Vice Mayor Lauritano closed Public Hearing at 7:03 p.m.

- >Council is open to look at change.
- >Density in this area will help us be successful.
- >Appreciates that the Planning and Zoning Commission looked at the drive-through issue.
- >Appreciates the pictures of possible designs of the homes.

7.3 17-6066 SPECIAL USE PERMIT TO ALLOW THE INSTALLATION OF A WIRELESS COMMUNICATION FACILITY SELF-SUPPORTING TOWER ON SR238 IN MOBILE

Vice Mayor Lauritano opened the Public Hearing at 7:10 p.m.

Katie Wilken, Planning Manager, presented. Special Use Permits are required for all new wireless communication facilities (WCF). Wilken presented details of a 195 foot self-supporting tower that is proposed in Mobile along the SR-238 on the Union Pacific Rail Road Right-of-Way.

There being no public comment, Vice Mayor Lauritano closed the Public Hearing at 7:14 p.m.

Council Discussion:

>Is there a certain height that is required to make sure that planes don't hit the tower?

Daniel Dean, representing the applicant responded that the reason the tower is so high is because the higher the tower, the wider the coverage. There is basically no coverage in this area now. If it is over 199 feet, the FAA requires that it be lighted, otherwise, it does not need to be lighted.

- >It looks like it is located in between two roads. Dean replied that it is located within a railroad right-of-way.
- >Appreciates that this will provide better cell phone coverage to Mobile.
- >Asked what the normal limit for a cell tower height? Wilken responded that there is no height limit for a cell tower, but typically they are about 65 feet.
- >Not thrilled about the chain link fence look. Will razor wire be installed? Dean responded that they will install barbed wire on the top of the fence.
- >Asked why this spot was picked. Dean responded that they are looking toward the future. The coverage issue is with Mobile and the primary objective is to provide coverage to people who are traveling along SR-238.
- **>How soon will this be installed?** Dean responded they plan to have it installed in about two months.
- >Can this tower be used for multiple carriers? Dean responded that it is engineered for four

carriers.

- >Concerned about the 30-year time frame for the agreement.
- >Asked if the chain link fence be revisited within the 30-year time frame due to aesthetic concerns. City Attorney Massey advised that if Council wants this changed, they should do it tonight. Wilken stated that staff is comfortable with the chain link fence because a block wall could invite graffiti, and a chain link fence provides more security.

7.4 <u>17-6058</u> <u>SPECIAL USE PERMIT TO ALLOW AN INERT MATERIAL</u> LANDFILL

Vice Mayor Lauritano opened the Public Hearing at 7:46 p.m.

Karen Craver, Planner III, presented.

On March 27, 2017, the City Council, upon recommendation of the Planning & Zoning Commission, adopted Ordinance No. 17-1342 approving a zoning ordinance text amendment to allow inert material landfills in any zoning district by Special Use Permit.

Fusaro, LLC, a land reclamation company out of Colorado, has submitted this Special Use Permit request to obtain approval to continue and complete reclamation of the existing borrow pit the company purchased at Roosevelt Street and 158th Avenue. The borrow pit was originally excavated during the construction of I-10 many years ago, and the initial reclamation project, by the previous owner, began approximately 10 years ago. Reclamation will be done in three phases lasting approximately five years.

Neighborhood Concerns were heard and will be addressed as follows:

Dust

- -A County dust control permit will be required
- -A County number to call will be posted on site
- -A 12,000 gallon water tank will be kept on site
- -A heavy cloth mesh will be attached to the site perimeter fence

Noise

-White noise back-up alarms will be used on all Fusaro equipment

- -Maximum noise level at property lines will be enforced
- -Limitations on when activities can occur will be enforced

Truck Traffic

- -All trucks will enter and exit via Roosevelt Street
- -Limitations on when deliveries of material can occur will be enforced
- -Roosevelt Street will be paved west of 158th Avenue to project entrance
- -No parking signs will be placed on Roosevelt west of 158th leading to Wade Acres
- -A permanent track-out pad shall be maintained

Brian Greathouse, representing Fasaro, spoke in favor of the project.

There being no public comment, Vice Mayor Lauritano closed the Public Hearing at 7:53 p.m.

Council Discussion:

- >Appreciates that the applicant worked with staff and neighbors in the area about their concerns.
- >Want to make sure that if anyone gets into the project area, that they wont hurt themselves on jagged debris that may be sticking out of the ground.
- >Happy there will be extra security for the area.
- >Asked how many trucks will be entering and exiting per day. Greathouse responded about 35 trucks per day.
- >How long will it take to complete the project? Greathouse estimated it will take five years.
- >Asked if there will be signage provided in the area alerting residents to truck traffic. Greathouse responded they will be happy to add signage if necessary.
- >Happy we are removing this neighborhood eyesore.

7.5 <u>17-6017</u> LAS BRISAS PHASE 2 PAD AMENDMENT

Vice Mayor Lauritano opened the Public Hearing at 8:05 p.m.

Katie Wilken, Planning Manager, presented.

The proposed Amendment to the Las Brisas PAD has two major action items:

- 1. Rezone Parcels 2B.1, 2B.2, and 2B.3 to existing zoning districts already allowed within Las Brisas Phase 2; and,
- 2. Create a new district in Las Brisas Phase 2 named SF-5,850 and rezone Parcel 2C.5 to this

district.

The original Las Brisas Phase Two PAD included five different lot sizes:

- >10,000 SF (80 foot min. lot width)
- >8,400 SF (70 foot min. lot width)
- >7,800 SF (65 foot min. lot width)
- >7,000 SF (60 foot min. lot width)
- >6,400 SF (55 foot min. lot width)

The proposed amendment eliminates the 10,000 SF (80 foot min. lot width) from the development plan, introduces a new zoning district, SF-5,580 (50 foot min. lot width), and establishes additional design requirements in order to enhance the design of smaller lots.

The design enhancement requirements that have been included are consistent with what has been required of other west Goodyear communities that have recently requested smaller lot sizes. Wilken showed a chart that depicts the land use changes proposed for the parcels.

Staff recommends that Council adopt Ordinance 17-1341, striking Stipulation No. 8. Stipulation No. 8 has to do with the dedication of a roadway (Dunlap on the north). This was mistakenly carried over from the original zoning and no longer applies. The property owner does not own that future right-of-way and they are unable to dedicate it.

Susan Demmitt, representing Gammage and Burnham, spoke in favor of the PAD Amendment.

There being no further public comment, Vice Mayor Lauritano closed the Public Hearing at 8:17 p.m.

Council Discussion:

>Concerned about the 8-10 minute fire station response time. Chief Luizzi stated that the new fire station is scheduled to open in July 2021. Staff is looking into the possibility of adding more response vehicles to the fire station located at Yuma Road and Sarival Avenue to meet the needs of the area until the new fire station is constructed.

>Glad to see that smaller lot sizes are being provided for that growing market.

Ozlanski also reviewed future projections for Public Art expenditures.

Council Discussion:

- >Not in favor of budgeting \$385,000 for the Recreation Campus until it is actually in progress.
- >Art at the proposed fire station needs to be planned so that it blends in with the community.
- >Art adds a lot to our community.

PUBLIC IMPROVEMENT CORPORATION SUBORDINATE LIEN MUNICIPAL FACILITIES REVENUE BONDS, TAXABLE SERIES 2017 TO FINANCE THE IMPROVEMENT, EXPANSION AND REFURBISHMENT OF CERTAIN BALLPARK FACILITIES AND RELATED FACILITIES

Doug Sandstrom, Finance Director, presented.

This proposed plan authorizes the city's execution and delivery of all documents required for the Public Improvement Corporation (PIC) to issue bonds for an approximate amount of \$11,000,000, either through a private bank placement or public offering, including providing for certain representations and certifications regarding the City's subordinate pledge of its Excise Taxes. It also authorizes the negotiation and preparation of an amendment to the Facilities Agreement with the Cleveland Indians establishing an annual rent payment equal to the debt service on the Bonds. The proceeds of the Series 2017 Obligations will provide funds to acquire and construct certain equipment and improvements to the existing Major League Baseball spring training facilities located in the city currently under lease to the Cleveland Indians. The current lease expires on December 31, 2029. Two five-year extensions are available. Terms of loan must be within the period covered by the lease.

The Cleveland Indians Development Complex expansion is proposed to be approximately 16,000 square feet and will include strength/conditioning, kitchen, equipment room, multi-purpose space, lockers, and office space. It will also expand the physical therapy and rehabilitation capacity. The building expansion will serve as collateral for the loan. The Indians will pay 100% of the costs associated with issuing the loan and the annual debt service.

This finalized agreement will be brought back for council consideration on May 22, 2017.

Sandstrom introduced Ryan Lantz with the Cleveland Indians who recapped the Indians' Development Complex expansion and renovations. This project will allow them to entertain more staff, players and visitors in Goodyear during Spring Training and year round. There will be economic benefits with hotels, retail, and entertainment opportunities. The updated complex can be used as a year-round community asset.

Council Discussion:

- >Clarified that if the agreement is not approved by Council on May 22nd, the bond sale will not take place.
- >Clarified that there is a ten percent debt limit associated with PIC funds and this pass-through agreement would apply against that amount.
- >The value in using city money is that we can get the money cheaper. There is also a tax benefit for the Indians with a lease agreement. This provides value to them with tax breaks.
- >Would like to see a 15-year agreement instead of 10 years to provide a win/win with a strong partnership standpoint in tying it to our debt service.
- >Asked about facility use during construction. Lantz stated they will be moving to the ballpark during construction and get creative with using various conference rooms and the team

shop at the ballpark.

City Attorney Massey stated that there is an emergency clause associated with this Ordinance and six members of Council are needed to vote on this. Staff called Mayor Lord and Councilmember Hohman so they could be part of the vote.
