7. OLD BUSINESS

7.1 <u>17-350-00004</u> <u>SPECIAL USE PERMIT FOR AN RV AND SELF-STORAGE</u> FACILITY AT PV303

Vice Chairman Barnes continued the public hearing from the June 14, 2017 meeting at 6:22 p.m.

Planner II Alex Lestinsky presented the request for a special use permit to allow a self-storage facility at the northwest corner of Indian School Road and 169th Drive in the PV303 development, subject to stipulations. Staff finds the special use permit request is compatible with the existing and planned land uses within the area and will not be a detriment to surrounding properties or persons. The proposal meets the conditions and required findings for a special use permit as contained within the Zoning Ordinance.

Applicant Stephen Earl, on behalf of Dollar Self Storage, presented to the Commission further information about the facility and design for both residential and business use.

There being no public comment, Vice Chairman Barnes closed the public hearing at 6:31 p.m.

8.1 <u>17-PZ001</u> <u>GOODYEAR COMMUNITY HEALTH PARK</u>

At the request of staff and permitted by the 7.1 applicant and Commission, item 8.1 was presented prior to Old Business item 7.1.

Management Assistant Diana Camacho presented to Commission the Goodyear Community Health Park Conceptual Master Plan that will be brought before City Council to adopt next week. The park is designed to promote healthy lifestyles and wellness. The presentation is informational and no action will be required of the Commission.

Charles Anderson of Charles Anderson Landscape Architecture was present to share the design plans for what is now being referred to as Wellspring Park. Mr. Anderson described each of the seven precincts: Engagement/Spectacle, Challenge/Discovery, Water Play/Fitness, Meditation/Observance, Therapeutic/Healing, Challenge/Adventure, Water Play/Immersion.
