PROPOSED ACTION:

Approve a request from Kim Kwiatkowski, agent for Circle K Stores Inc., dba Circle K Store #9528, for a new Series 10 liquor license #10076905, located at 1550 N. Pebble Creek Parkway, Goodyear, Arizona 85338 (Generally located at the southwest corner of Pebble Creek Parkway and McDowell Road).

BACKGROUND AND PREVIOUS ACTIONS:

Mr. Kwiatkowski has applied for a new Series 10 liquor license for a future Circle K store. The store is tentatively scheduled to begin construction in approximately one year. The company is in the process of purchasing the property, but they must secure an alcohol license prior to purchase. Circle K currently has 577 convenience stores in Arizona, and all of these stores are company operated.

The City Clerk's Office received the application from the Arizona Department of Liquor Licenses and Control on August 28, 2017. The application has been routed to the Police, Fire, Code Enforcement and Development Services, and any comments are listed on Attachment A.

The application has been properly posted on the property for the State-mandated 20-day period. Any petitions or protests pursuant to A.R.S. §4-201(b) received during the 20-day posting period will be added to this report.

STAFF ANALYSIS:

Staff has been informed that a manager will be onsite to oversee alcohol sales. Circle K trains their employees in their company's "AZ Restricted Sales Policy" (attached) in order to comply with the law restricting alcohol sales to minors.

There are no schools located within 300 feet of this location.

A Series 10 License is for a Beer and Wine Store and is non-transferable. It allows a retail store to sell beer and wine (no other spirituous liquor), only in the original unbroken package, to be taken away from the premises of the retailer and consumed off the premises.

The City Council's recommendation of approval, disapproval or no recommendation will be forwarded to the Department of Liquor Licenses and Control ("Department") for their consideration. If the City Council recommendation is for approval, no hearing is required unless the Director of the Department, the State Liquor Board ("Board"), or any aggrieved party requests a hearing on the grounds that the public convenience and the best interest of the community will not be substantially served if a license is issued. If no hearing is requested, the Director may approve the license. If the City Council recommendation is for disapproval of an application, a statement of the specific reasons along with a summary of the testimony or other evidence supporting the recommendation for disapproval shall be attached to the order of disapproval and submitted to the Director and a public hearing will be held.

If the City Council recommendation is no recommendation, the Director may cancel the hearing and issue the license unless the Board, or any aggrieved party, protests and requests a hearing. If the reason for the protest is clearly removed or deemed satisfied by the Director, the Board shall cancel the hearing and the Department may issue the license.

FISCAL ANALYSIS:

The applicant has paid the \$635.00 application fee for the license per the Goodyear Municipal User Fee Schedule. This business will contribute to the tax base of the community.

RECOMMENDATION:

Staff recommends approval of the Series 10 liquor license.


