## 5.2 Brief update on board activities. (Doug Sandstrom, Finance Director)

Finance Director Doug Sandstrom provided the following update:

- >Current cash balance of approximately \$52,310.
- >Bond Issues:
- Water and Sewer Revenue Bonds (Litchfield Park Service Company Project), Series 2001.
- Water and Sewer Revenue Bonds (Litchfield Park Service Company Project), Series 1999.
- o Received 10 Basis Points for an administrative fee which is \$12,855 annually. The final administrative payment was due and was paid and fully redeemed in October 2015.
- o The IDA no longer receives any fees from that borrower.
- >FY17 Revenues \$9.61 to date (interest).
- >FY17 Expenditures \$0
- o Currently no expenditures planned.
- >IDA has authority to enter into contracts and employ professionals to further its business. Many IDAs will engage in marketing to attract potential projects, and will also send staff to conferences for training purposes/ marketing.
