NOTICE IS HEREBY GIVEN that, pursuant to Section 8.8(B) of (i) the Indenture of Trust and Security Agreement, dated February 1, 2001 (the "2001A Indenture"); (ii) the Indenture of Trust and Security Agreement, dated December 1, 2002 (the "2002 Indenture"); (iii) the Indenture of Trust and Security Agreement, dated July 1, 2007 (the "2007 Montecito Indenture"), and (iv) the Indenture of Trust and Security Agreement, dated December 1, 2007, (the "2007 Golf Village Indenture", and together with the 2001A Indenture, the 2002 Indenture and the 2007 Montecito Indenture, collectively, the "Indenture") all by and between Estrella Mountain Ranch Community Facilities District (City of Goodyear, Arizona) (the "Issuer"), and Wells Fargo Bank, N.A., formerly known as Wells Fargo Bank Arizona, N.A., Wells Fargo Bank, National Association hereby resigns as Trustee, Transfer Agent, Paying Agent, and Bond Registrar (in all such capacities, the "Trustee") under the Indenture effective **November 15, 2017**.
