Chairman Stipp adjourned the Executive Session at 8:25 a.m.

### 5.2 Reconvening of Fire Board Meeting

Chairman Stipp reconvened the Fire Board Meeting at 8:25 a.m.

### 5.3 Fire Board will consider accepting an Accidental Disability Application for Christina Yohe.

Boardmember Doyle noted that Christina's last name was Emerson when she was hired with the city in 2005. The December 15, 2005 minutes stated that Christina didn't have any pre-existing conditions.

Chairman Stipp said there was conflicting information in the medical documentation where none of the doctor's names matched in the August 2016 Independent Medical Exam from Dr. Maxwell. Dr. McLean was listed in the documentation, however, Ms. Yohe stated she never saw Dr. Mclean. She saw Physician Assistant Roseman. Chairman Stipp said he wants to make sure there is consistent medical history.

In April 2017 an Independent Medical Exam was done by Copperpoint. Yohe had gone back to physical therapy and it stated Ms. Yohe was not improving. Other than the disectomy, she deferred all injections and epidurals at that time.

Ms. Kelly stated there is an issue if it is a reasonable procedure to have done which is one thing, but if it is back surgery then it may not be reasonable to do and could be risky.

Yohe stated that she chose not to do the injections because given what her work entails, she didn't want to mask the pain and further injure herself. After reviewing the pros and cons of the injections, she chose not to go that route.

Boardmember Doyle stated that the physical therapy and further treatments seemed to make her condition worse.

Chairman Stipp said a herniated disk could shrink with injections but we don't know. Have we done everything we can to get back to work? He isn't 100% sure that we have done everything.

Boardmember Doyle said that there is another issue of the umbilical hernia that occurred during this time. In his experience, a back injury is related to abdominal injuries. This plays a role in the senario since the June 25, 2015 injury. Ms. Yohe said this wasn't treated through Worker's Compensation for the umbilical hernia.

Chairman Stipp said there are three options.

- \*To accept the disability application and send for an Independent Medical Exam
- \*To deny the disabilty application
- \*To table the disability application

MOTION by Boardmember Doyle, SECONDED by Boardmember Mathias, to ACCEPT the Disability Application for Christina Yohe and send her for an Independent Medical Exam to include questions for the IME doctor. The motion carried by the following vote:
