A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, APPROVING THE EXECUTION OF AN AGREEMENT PROVIDING FOR THE DONATION OF THE CITY'S SURPLUS 2001 CHEVROLET BRUSH TRUCK TO THE GILA BEND FIRE DEPARTMENT FOR USE IN EMERGENCY RESPONSE.

WHEREAS, the city is currently in possession of and lawfully owns a 2001 Chevrolet Brush Truck, VIN 1GCJK34141E307808 ("Vehicle"), which has been used by the city of Goodyear Fire Department;

WHEREAS, the city is no longer in need of the Vehicle and desires to transfer ownership of the Vehicle to the Gila Bend Fire Department subject to the terms and conditions contained in a donation agreement;

WHEREAS, The Gila Bend Fire Department is a volunteer fire department with a history of mutual aid responses with Goodyear Fire Department;

WHEREAS, The Gila Bend Fire Department would benefit from the donation of the Vehicle by upgrading their fleet;

WHEREAS, The Vehicle includes a single band fire radio which would enable emergency fire ground radio communications between the two departments;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The attached city of Goodyear and Gila Bend Fire Department Donation Agreement CON-18-4268 ("Donation Agreement") is hereby approved.

SECTION 2. The city is authorized to donate the city's surplus 2001 Chevrolet Brush Truck to Gila Bend Fire Department for use in emergency response subject to the terms and conditions of a donation agreement.

SECTION 3. The City Manager or designee is authorized to take all actions and execute any and all documents necessary to carry out the intent of this Resolution and the Donation Agreement.
