6. **BUSINESS**

6.1 EMRCFD AUTHORIZATION FOR REFUNDING OF ESTRELLA MOUNTAIN 2018-556 RANCH CFD (GOLF VILLAGE ASSESSMENT DISTRICT NO. 2) SAD BONDS, SERIES 2018

District Treasurer Doug Sandstrom presented all four business items together.

The Board is being asked to adopt resolutions authorizing the issuance and sale of Estrella Mountain Ranch Community Facilities District Special Assessment refunding bonds, Series 2018 for Golf Village I, Golf Village II, Montecito, and Desert Village. The purpose is to reduce the District's overall debt service. There will be no change to current assessments, and this will shorten the life of the debt by one to three years.

The estimated savings will be approximately \$3.4 million. The refunding bonds will be secured by a lien on each parcel within the assessment area. Mr. Sandstrom reviewed the amounts of the refunding by assessment area.
