# 6.1 <u>CFUD#1</u> <u>AUTHORIZING THE DEFEASANCE OF A PORTION OF THE</u> 2018-560 <u>COMMUNITY FACILITIES UTILITIES DISTRICT NO. 1 G. O.</u> <u>REFUNDING BONDS, SERIES 2014</u>

District Treasurer Doug Sandstrom presented the defeasance of \$2.8m utilizing the special reserve fund established under Suncor Bankruptcy for Community Facilities Utilities District No. 1. The defeasance takes funds that we currently have on hand that are currently restricted from the bankruptcy of Suncor for the payment of debt and puts them into an irrevocable trust. The irrevocable trust will then make debt service payments on the city's behalf for that portion of bonds that have been defeased, thereby lowering our debt service for the next few years and lowering the required tax rate for it. The tax rate has been running \$1.15 per \$100 of assessed valuation. By taking this money and putting it in the trust, it will lower that anticipated tax rate by .15, down to the targeted \$1.00 for this district.
