- Property tax levied to pay for debt and operations/maintenance


FY19 CFD Tentative Budgets

Community Facilities General District No. 1, Palm Valley Community Facilities District No. 3 and Community Facilities Utilities District No. 1



Wildflower Ranch Community Facilities District and No. 2, Cottonflower Community Facilities District, Centerra Community Facilities District and Cortina Community Facilities District


Community Facility Districts Cottonflower, Wildflower, Centerra, & Cortina Districts

FY19 CFD Tentative Budgets

- Arizona Revised Statute 35-458
 - Limits fund balances to 10% of annual debt service
 - Will make July 15, 2018 payments in June 2018
 - Affects seven CFDs in FY19
 - Call bonds when available
 - Lower property tax levy
