6. **BUSINESS**

Chairman Lord announced at 4:47 p.m. that the Community Facilities District Board will conduct one public hearing for all ten Community Facilities Districts to receive comments regarding any of the final expenditures and tax levy for Fiscal Year 2018-2019 (FY19), and setting a hearing date.

Finance Manager Jared Askleson presented. Community Facilities Districts are special districts created to build and finance infrastructure in specific district areas, which also levy a property tax to reimburse the debt service payments. Mr. Askelson reviewed the final budgets for each of the ten districts. All districts except for King Ranch show a reduction for FY19. This is because three debt service payments were made during FY18 and only two will be made in FY19. This is being done to bring the fund balances in line with State Statutes that were put in place last year. The levy amounts are sufficient to cover the operations and maintenance, as well as the debt service for each of the districts. Mr. Askelson reviewed the FY19 combined property tax rate, the outstanding General Obligation debt, and the average estimated tax levy for each of the districts.

Chairman Lord asked if anyone in the audience that would like to speak. There being no public comment, Chairman Lord called for the reading of the resolution titles and a vote at 4:52 p.m.
