## **RESOLUTION NO. 2018-1879**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, ADOPTING THE REVISED CITY OF GOODYEAR, ARIZONA CITY COUNCIL MEETINGS RULES OF PROCEDURE DATED JULY 2018.

WHEREAS, per the City Charter, the Mayor and Council have to put policies and procedures in place for conducting City Council Meetings; and

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona adopted the city of Goodyear, Arizona City Council Meetings Rules and Procedure on August 14, 2000 by Resolution 00-740; and

WHEREAS, the Mayor and Council approved subsequent revisions to the City Council Meetings Rules of Procedure document with the adoption of Resolution 16-1763 on July 11, 2016 and Resolution 16-1773 on November 21, 2016; and

WHEREAS, processes and procedures in the City Council Meetings Rules of Procedure periodically need to be updated; and

WHEREAS, before the adoption of Ordinance 2018-1392, any amendments to Articles 2-4 (Council Procedure) and 2-5 (Ordinances and Resolutions) of the Goodyear City Code often required corresponding amendments, and any changes to the City Council Meetings Rules of Procedure often required changes to Articles 2-4 and 2-5; and

WHEREAS, to avoid having to amend the Goodyear City Code to revise processes and procedures, Council adopted Ordinance 2018-1392; which removed various process and procedures related to Council meetings from Articles 2-4 (Council Procedure) and 2-5 (Ordinances and Resolutions) and replaced them with references to the City Council Meeting Rules of Procedure; and

WHEREAS, the City Council Meetings Rules and Procedure dated July 2018 being presented, revises the City Council Meeting Rules and Procedure to incorporate all prior revisions, to incorporate policies and procedures being removed from Articles 2-4 and 2-5 of the Goodyear City Code, removes processes more appropriately addressed in the City Clerks Standard Operating Procedures, removes provisions that are addressed in other adopted procedures or that are unnecessary; and provides for general cleanup of processes and procedures; and

WHEREAS, the Mayor and Council find the adoption of the amended city of Goodyear, Arizona City Council Meetings Rules of Procedure, hereto attached as Exhibit "A," will provide flexibility to the legislative process as well as promote the interests, convenience and general welfare of the citizens of the city of Goodyear;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

## SECTION 1. ADOPTION OF THE CITY OF GOODYEAR, ARIZONA CITY COUNCIL MEETINGS RULES OF PROCEDURE DATED JULY 2018

The Mayor and Council of the city of Goodyear hereby adopt the city of Goodyear, Arizona City Council Meetings Rules of Procedure dated July 2018, a copy of which is hereto attached as Exhibit "A."

#### SECTION 2. REPEAL

The city of Goodyear Arizona City Council Meeting Rules and Procedure adopted on August 14, 2000 by Resolution 00-740 and all amendments thereto are repealed.

### SECTION 3. EFFECTIVE DATE

This resolution shall become effective on the effective date of Ordinance 2018-1392.
