#### **PROPOSED ACTION:**

Approve a request from John Dean Curtis, II, agent for Blazin Wings, Inc., doing business as Buffalo Wild Wings, for an Acquisition of Control of Series 12 Liquor License No. 12079155, located at 13311 West McDowell Road, Goodyear, Arizona 85395 (Generally located at the 13300 block of West McDowell Road).

### **BACKGROUND AND PREVIOUS ACTIONS:**

Council approved Series 12 Liquor License No. 12079155 for Buffalo Wild Wings on July 9, 2012, and the license was issued by the Arizona Department of Liquor Licenses and Control (DLLC) on July 31, 2012. The City Clerk's Office was forwarded the current application on July 27, 2018.

#### **STAFF ANALYSIS:**

Buffalo Wild Wings recently underwent a change in its ownership structure; therefore, they are required to file an Acquisition of Control with the DLLC per A.R.S. § 4-203(F), a copy of which is attached as an exhibit.

The application has been routed to the Police Department and the Development Services Department (Planning and Zoning, Code Compliance and Building Safety), and no concerns were noted.

There are no licensed childcare facilities or K-12 schools within 300 feet of the location.

The City Council's recommendation of "Approval", "Disapproval" or "No Recommendation" will be forwarded to the DLLC for consideration at a public hearing of the State Liquor Board ("Board").

• **APPROVAL:** If the City Council recommendation is for approval, a hearing of the Board is not required unless the DLLC Director ("Director"), the Board, or any aggrieved party requests a hearing on the grounds that the public convenience and the best interest of the community will not be substantially served if a license is issued. If no hearing is held, the license may be approved by the Director.

- DISAPPROVAL: If the City Council recommendation is for disapproval of an application, a statement of the specific reasons along with a summary of the testimony or other evidence supporting the recommendation for disapproval shall be attached to the order of disapproval and submitted to the Director; a public hearing will then be held by the Board.
- NO RECOMMENDATION: If the City Council recommendation is "No Recommendation", the Director may cancel the public hearing and issue the license unless the Board or any aggrieved party requests a hearing. If the reason for the protest is clearly removed or deemed satisfied by the Director, the Board will cancel the public hearing, and the license may be approved by the Director.

## FISCAL ANALYSIS:

Per the Goodyear Municipal User Fee Schedule, a liquor license fee is only charged for new liquor licenses. Acquisitions of Control involve current liquor licenses; therefore, no fee is charged.

### **RECOMMENDATION:**

Staff recommends approval of the Acquisition of Control.
