

RESOLUTION NO. 2018-1891

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DECLARING AS A PUBLIC RECORD THOSE CERTAIN DOCUMENTS FILED WITH THE CITY CLERK TITLED “SUPPLEMENTARY ZONING MAP 18-04A CITY OF GOODYEAR, AZ – REZONE CASE DATED JULY 2018”; “PEBBLE CREEK MARKETPLACE MIXED USE PHASE II PARENT PARCEL LEGAL DESCRIPTION”; AND “PEBBLE CREEK MARKETPLACE MIXED USE PHASE II – PAD DEVELOPMENT REGULATIONS DATED JUNE 25, 2018.”
