## **RESOLUTION NO. 2018-1890**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY MANAGER, OR HER DESIGNEE TO AMEND THE RESTATED INTERGOVERNMENTAL AGREEMENT TO PLAN, DESIGN, CONSTRUCT, OPERATE, MAINTAIN AND FINANCE THE REGIONAL WIRELESS COOPERATIVE (RWC) NETWORK IN ORDER TO REPLACE THE EXISTING RWC GOVERNANCE DOCUMENT WITH A NEW GOVERNANCE DOCUMENT EFFECTIVE JANUARY 1, 2019, WHICH AMENDS THE RULES AND POLICIES GOVERNING THE REGULATION AND MANAGEMENT OF THE RWC INTERNAL AFFAIRS.

WHEREAS, the Parties wish to amend the rules and policies governing the regulation and management of the RWC's internal affairs, which rules are presently set forth in Exhibit A to the Agreement, by replacing said Exhibit A with the document attached as Exhibit A hereto; and

WHEREAS, the Mayor and Council of the city of Goodyear, Arizona deem it appropriate to make several additional revisions to the body of the Agreement in order to accommodate the revision of Exhibit A; and

WHEREAS, the city of Goodyear has been a partner with the Regional Wireless Cooperative since 2008.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

**REPLACEMENT OF THE GOVERNANCE DOCUMENT:** Exhibit A to the Agreement is hereby deleted and replaced with the Regional Wireless Cooperative Governance Document attached as Exhibit A hereto.

## SECTION 1. Section 4.4, first sentence within the second paragraph

Is hereby deleted and replaced with the following "The Parties agree that all damages, costs and expenses not specifically provided for in this Agreement shall be shared by the Parties in proportion of each Party's share of the total number of Subscriber Units at the time of the claim or lawsuit is first served on any Party or the unforeseen costs or expenses were incurred (whichever occurs first)"

## SECTION 2. Section 4.8, fourth sentence

Is hereby deleted and replaced with the following: "The costs of any insurance and/or self-insurance provided under this section shall be shared by the Parties pursuant to Section 3.3.2 of Exhibit A."
