RESOLUTION NO. 2018-1899

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT (IGA) FOR A MULTI-CITY HOUSEHOLD HAZARDOUS WASTE (HHW) COLLECTION DAY EVENT BETWEEN THE CITIES OF GOODYEAR, LITCHFIELD PARK, AVONDALE, AND TOLLESON.

WHEREAS, Goodyear, Avondale, Litchfield Park and Tolleson desire to work cooperatively to hold semi-annual hazardous waste events in the fall and spring; and

WHEREAS, entering into a collaborative multi-city event would be beneficial to the health and safety of the communities and the environment; and

WHEREAS, the IGA addresses the terms applicable to jointly coordinate, plan, promote and administer the household hazardous waste events. Goodyear will host one event annually during the fall in the month of October or November, and Avondale will host a second event annually during the spring in the month of March or April. The cities will work cooperatively to schedule the event and each city will maintain the right to opt out of participating in any event upon 60 days written notice to the other cities prior to the event; and

WHEREAS, the term of the IGA will be for three (3) years from and after the effective date; and

WHEREAS, the cities will jointly coordinate the event planning, development, and administration of the events; and

WHEREAS, Goodyear shall procure the services of a qualified contractor to conduct the Goodyear event and ultimate disposal of the hazardous waste pursuant to a separate contractual agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:
