PROPOSED ACTION:

ADOPT RESOLUTION NO. 2018-1899 AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT (IGA) FOR A MULTI-CITY HOUSEHOLD HAZARDOUS WASTE (HHW) COLLECTION DAY EVENT BETWEEN THE CITIES OF GOODYEAR, LITCHFIELD PARK, AVONDALE, AND TOLLESON.

BACKGROUND AND PREVIOUS ACTIONS:

For the past six years, through a similar IGA, the cities of Litchfield Park, Avondale, Goodyear, and Tolleson have worked cooperatively to hold semi-annual HHW events. The events are held in the fall and spring with Goodyear and Avondale alternately hosting the events. These events have become increasingly popular over the years with the annual participation increasing from 598 vehicles in 2013 to 1,168 in 2017.

STAFF ANALYSIS:

The purpose of this Agreement is to work cooperatively with southwest valley cities to hold a semi-annual event to collect and dispose of household hazardous waste material in an effort to protect human health and the environment. Goodyear will host one Event annually during the fall in the month of October or November, and Avondale will host a second Event annually during the spring in the month of March or April. The Cities will work cooperatively to schedule the Event and each City will maintain the right to opt out of participating in any Event upon 60 days written notice to the other Cities prior to the Event.

Through the cooperation of a multi-city event the cities recognize an economy of scale in the collection and disposition of materials as well as share in the staffing requirements. Without a multi-city agreement such as these smaller cities might not be able to offer this service to their citizens which could lead to improper disposal.

FISCAL ANALYSIS:

The FY19 budget for household hazardous waste events is \$75,000 in the Sanitation operating funds.

RECOMMENDATION:

Staff recommends Council adopt Resolution No. 18-1899 authorizing the City Manager to execute an Intergovernmental Agreement (IGA) for a Multi-City Household Hazardous Waste (HHW) Collection Day Event between the Cities of Goodyear, Litchfield Park, Avondale, and Tolleson.
