PROPOSED ACTION:

ADOPT RESOLUTION NO. 2019-1943 DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL/PRIMARY ELECTION HELD ON MARCH 12, 2019; DECLARING THE ELECTION OF THREE COUNCILMEMBERS; DECLARING RESULTS ON THREE PROPOSITIONS; AND ORDERING THE CITY CLERK TO RECORD THIS RESOLUTION.

BACKGROUND AND PREVIOUS ACTIONS:

On October 1, 2018, City Council called for a Special/Primary Election and referred three propositions to the voters. The Special/Primary Election took place on March 12, 2019.

Turnout for elections for the last ten years is as follows:

STAFF ANALYSIS:

Per A.R.S. § 16-642, the city is required to canvass the vote of the election not less than six (6) days nor more than twenty (20) days following the election.

A.R.S. § 9-821.01 and Goodyear City Charter, Article IX, Section 6, both set forth that a candidate who receives a majority of votes in the primary is declared elected.

FISCAL ANALYSIS:

Adopting Resolution No. 2019-1943 has no direct fiscal impact.
