## **RESOLUTION NO. 2019-1943**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL/PRIMARY ELECTION HELD ON MARCH 12, 2019; DECLARING THE ELECTION OF THREE COUNCILMEMBERS; DECLARING RESULTS ON THREE PROPOSITIONS; AND ORDERING THE CITY CLERK TO RECORD THIS RESOLUTION.

WHEREAS, the city of Goodyear City Council called for an election and submitted three ballot measures to the voters on October 1, 2018; and

WHEREAS, the city of Goodyear held a Special/Primary Election on Tuesday, March 12, 2019, for the purpose of electing three Councilmembers and determining if changes should be made to the City Charter; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election not less than six (6) days nor more than twenty (20) days following the election; and

WHEREAS, the election returns have been presented to, and have been canvassed by, the Goodyear City Council;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The total number of votes cast at said Special Primary Election minus Write-ins for whom no timely nomination papers were filed was 10,205. (Exhibit A)
- <u>SECTION 2.</u> The total number of rejected and late ballots was 73. (Exhibit B)
- <u>SECTION 3.</u> The votes cast for the candidates for Councilmember were as follows (Exhibit A):

Sheri Lauritano	7,864
Bill Stipp	8,101

<u>SECTION 4.</u> That it is found, determined, and declared of record that the following candidates received the greatest number of votes cast for the office of Councilmember and shall be issued a certificate of election.
