6.1 Announcements (John Raeder, Assistant to the Council)

Assistant to the Council John Raeder updated the Commission on the Culture Pop event held on February 9. The Goodyear Youth Commission collected \$30 in proceeds from the sale of soda and water during the event. The Youth Commission recommended the \$30 be donated to support the Homeless Youth Connection.

Mr. Raeder also announced that staff was exploring opportunities for the Youth Commission to participate in a Day at the Capitol in April and the Governor's Youth Leadership Day on May 3, 2019.

6.2 Goodyear Ballpark Mascot Discussion (John Raeder, Assistant to the Council)

Mr. Raeder stated that Goodyear Ballpark announced a campaign on social media to name the new Goodyear Ballpark mascot. The Ballpark received 250 unique name submissions for the mascot via social media.

The Youth Commission reviewed the submitted names and chose their top names for consideration.

6.3 Goodyear Police K9 Presentation (Sgt. Bradley Hardin, Goodyear PD)

Goodyear Police Sgt. Hardin provided a presentation on the Goodyear K9 Unit. He discussed the breed of dogs, how they are trained, and their role in assisting law enforcement. Sgt. Hardin also provided examples of specific K9 operations and answered commissioner questions.
