# 7.2 <u>2019-6621</u> <u>ORDERING THE SALE OF THE CITY OF GOODYEAR, ARIZONA, GENERAL OBLIGATION BONDS, SERIES 2019</u>

Jared Askelson, Finance Manager, presented. Mr. Askelson said the Resolution authorizes the sale of new 2019 Series Bonds in the amount of \$27 million to pay for the construction of the recreation aquatic center, the replacement of fire station 181, and the police radio system project. He said debt service on the bonds will be paid from the secondary property tax levy and structured in accordance with the adopted financial policies.

The Mayor Recessed the meeting at 6:23 p.m. The Mayor called the meeting to order at 6:27 p.m.

City Attorney Roric Massey said he reviewed Councilmember Hampton's recusal. Mr. Massey said based on the current status of his employment and not being involved in this issuance there is no need for recusal.

#### 7.3 <u>2019-6619</u> <u>GOODYEAR CIVIC SQUARE AT ESTRELLA FALLS PROJECT</u>

City Manager Julie Arendall presented on the Goodyear Civic Square project. Ms. Arendall said the proposed Letter of Intent (LOI) would be the first step to create a public-private partnership between the city of Goodyear and Globe Corporation. She said the project would include a City Hall with Library, 2-acre park and gathering place, and a Class A speculative office product. Ms. Arendall said tonight's proposal includes a request to authorize a budget transfer to fund initial programming for the project.

Ms. Joanne Osborne addressed the City Council. Ms. Osborne said she is a business owner in Goodyear and believes the project will revitalize the area. She said she supports the public private partnership as presented.

#### **Council Discussion:**

- > Council expressed support for the project and said the project will help spur quality development in this area.
- > Council thanked Globe Corporation and city staff for their work on this proposal.
- > Council commented on the vision of creating a gathering place for the community as a part of this project.

#### 7.4 2019-6626 JOB CREATION AGREEMENT FOR FAIRLIFE, LLC

Harry Paxton, Economic Project Manager, presented to the Council. Mr. Paxton said Fairlife purchased 54 acres in Goodyear and plans to begin construction on a 300,000 square-foot facility opening in 2020. He said Fairlife plans to invest a minimum of \$200,000,000 in the project.

Mr. Paxton said a third-party economic analysis was conducted showing the direct tax benefit to the city of Goodyear from sales taxes, real and personal property tax, net permit & impact fees generated by Fairlife for Phase I. He said the benefits to the community include creating at least 140 full-time jobs in Goodyear, paying employees an annual salary/wage of at least \$40,000 per year, and a capital investment of at least \$200,000,000. Mr. Paxton said the agreement waives plan review and permit fees, and the expedited portion of fees up to a maximum of \$900,000.

Ms. Joanne Osborne addressed the City Council. Ms. Osborne said the State of Arizona has also been studying this industry. She said the Land Agriculture Committee recently passed a bill related to the number of dairy inspectors required.

Mayor Lord thanked Representative Osborne for her comments.

#### **Council Discussion:**

> Council welcomed the Fairlife company to the city of Goodyear and stated the city looks forward to a long partnership.
