# 8.2 19-210-00002 CHRISTOPHER TODD COMMUNITIES AT CANYON TRAILS PAD AMENDMENT

Chairman Bray opened the public hearing at 6:03 p.m.

Planner III Eva Cutro presented the request to recommend approval to rezone approximately 22 acres of land located at the southeast corner of 173rd Avenue and Van Buren Street from Final Planned Area Development (PAD) District to Final Planned Area Development (PAD) District by amending the Christopher Todd Communities at Canyon Trails PAD to allow for increased height. The request is to increase the height of the residential main structures from "16'/one story" to "20'/one story". All other PAD standards will remain the same. The elevations and architectural style of the residences do not change. The applicant has stated that the height listed in the approved PAD was erroneous as the applicant was unclear on how the City measured height. The applicant was using a measurement "to the average height between the peak and the eaves on a building with a hip or gable roof" as this is a measurement that they used in other cities. Staff finds the rezone to amend the Christopher Todd Communities at Canyon Trails PAD is in conformance with the General Plan and will not adversely affect the surrounding area. As such, staff recommends approval of the conditional rezoning pursuant to Ordinance No. 2019-1431.

Applicant Andy Jochums of Beus Gilbert further explained the error and clarified the reason for the PAD amendment.
