RESOLUTION NO. 2019-1966

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, APPROVING THE INTERGOVERNMENTAL AGREEMENT (IGA) BETWEEN THE CITY OF PHOENIX AND CITY OF GOODYEAR FOR EMERGENCY DISPATCH SERVICES; AND AUTHORIZE THE CITY MANAGER OR HER DESIGNEE TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY FOR THE ADMINISTRATION OF THE IGA.

WHEREAS, the city of Goodyear has a desire to enter into an Intergovernmental Agreement (IGA) for participation in the Phoenix Fire Regional Dispatch System; and

WHEREAS, the City of Phoenix Fire Department provides dispatch services to various fire departments throughout the Phoenix metropolitan area; and

WHEREAS, the Goodyear Fire Department has been dispatched by the Phoenix Fire Department since January 6, 1999 for emergency incidents, providing the highest possible level of technology and resources for fire and ambulance dispatching; and

WHEREAS, the Goodyear Fire Department seeks to provide the most efficient, safe and effective fire-rescue-emergency medical services to the community; and

WHEREAS, it is the desire of both municipalities to enter into this agreement for continued dispatch services;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The parties hereto acknowledge that this Agreement is being entered into pursuant to the Intergovernmental Agreement Statue, A.R.S § 11-952.
- SECTION 2. The Phoenix Fire Department agrees to dispatch Goodyear Fire Department units on an automatic basis. The Computer Aided Dispatch and Automatic Vehicle Locator system will automatically determine the closet available units and dispatch accordingly.
- SECTION 3. It is agreed that the scope of this agreement includes dispatching assistance in responding to fires, medical emergencies, hazardous materials incidents, rescue and extrication situations and other types of emergency incidents that are within the standard of scope of services.
- SECTION 4. The Phoenix Fire Department Regional Dispatch System agreement shall commence upon the Effective Date as set forth in the Intergovernmental Agreement, and shall continue in force through December 31, 2027, or until terminated by formal act of the Parties.
